Subject: - Placement of Masters as Incharge Headmasters and equivalent----adjustment thereof.

**ORDER NO. 2767 DSEK OF 2015
DATED 18/11/2015**

Sanction is hereby accorded to the placement of **57 (Fifty Seven)** Masters shown in the **Annexure "A"** to this Order as Incharge Headmasters and equivalent in their own pay and grade for a period of **six months** or till clearance by Public Service Commission whichever be earlier. The official so promoted shall be entitled for drawal of charge allowance as admissible under rules.

Their placement shall be subject to the following conditions:-

- i. That the Masters hold genuine appointment in the Department and are not involved in any crime case pending investigation with Vigilance Organization/ Crime Branch or in the Department;
- ii. That the placement will, however, not confer any superior claim or right upon the Masters and shall be subject to outcome of any case pending adjudication in any Court of law and shall be without prejudice to seniority of others.
- iii. That the placement of the incumbents as Incharge Headmaster shall be operative only after physically joining the new assignment as shown in this order provided they have worked as Master physically for the requisite time period as envisaged in SRO 240 of 1979 Dated 23/04/1979 read with SRO 308 of 2008 Dated 16/10/2008.
- iv. It is further ordered that:-

Consequent upon the above, the officials shall immediately report to concerned Institutions/Offices as indicated against each in **Annexure "B"** for further duties and after verification of their service particulars as shown **Annexure "A"** to this Order by reference to relevant records by the Chief Education Officers concerned. In case any variation in respect of service particulars is detected, the same should be brought to the notice of this Directorate for further instructions. In that case, the implementation of the order be stopped till instructions are conveyed by this Directorate. The officials thus placed as Incharge Headmasters and equivalent shall invariably join their respective place of postings within a period of **10-days** for Kashmir based and **15-days** for Jammu based promotees. Any Master, failing to take up the higher assignment within the stipulated period shall be deemed to have forfeited the same assignment/placement.






