Moreover, in respect of S.No. 11, the DDO concerned shall implement the order only after ascertaining the genuineness of her ST status.

Seniority of the appointees shall be fixed as per CCA Rules (1956) and satisfactory qualifying of probation period.

This order is issued without prejudice to any writ petition/suit if any pending/sub-judice before the Hon'ble High Court or any other court of law.
