However, drawal of salaries shall be subject to the following conditions:

1. The Chief Education Officers/Drawing and Disbursing Officers shall strictly adhere to all the codal formalities, financial regulations and circular instructions issued from time to time in this regard.
2. Chief Education Officers shall ensure that further disbursement of funds to the Drawing and Disbursing Officers and subsequently drawal of salaries immediately without any further delay.
3. The respective Drawing and Disbursing Officers shall obtain an undertaking duly attested from RRET's to the effect that in case adverse report regarding character antecedents/genuiness of certificates is received they shall have to refund the salary drawn along with the interest.
4. The salary in favour of RRET's having 10+2 as their qualification and those having overlapping degrees shall be paid with a grade pay of Rs: 2400.
