Whereas, the Administrative Department vide letter No.Edu-I/85/2019 dated 23.04.2019 forwarded the list of 14 candidates selected as Teachers for District Cadre Budgam pursuant to the recommendations made by the J&K Services Selection Board, Srinagar vide their No.SSB/Secy/Sel/15/2019/1818-24 dated 08.03.2019 against Advertisement Notice No. 06 of 2017, dated 28.12.2017 (Item No. 032); and

Whereas, provisional appointment orders were issued in favour of all such candidates against whom recommendations were not kept withheld by the JKSSB or released subsequently; and

Whereas, a slot accrued due to non-joining of Mr. Gulzar Ahmad Najar figuring at S.No. 3/RBA in the selection list paving way for appointment of Mr. Manzoor Ahmad Raina S/o Gh. Mohi ud Din Raina figuring at S.No.2 in the waiting list under RBA Category; and

Whereas, vide this office communication No. DSEK/Estt/III/B-Trs/Sel/2019/612 dated 10.03.2021 followed by communication No. DSEK/Estt/III/B-Trs/887 dated 03.05.2021 the matter was taken up with the Administrative Department for obtaining authorization for operation of waiting list against the accrued slot; and

Whereas, the Administrative Department vide communication No. Edu-NG-K/19/2021 dated 02.06.2021 conveyed authorization for operation of waiting list in favour of Mr. Manzoor Ahmad Raina S/o Gh. Mohi ud din Raina figuring at S.No. 2/RBA/waiting for the post of "Urdu Teacher" in terms of SRO-60 of 2018 dated 02.02.2018, whose recommendation was released by JKSSB vide communication No. SSB/Secy/Sel/15/2019/2426-28 dated 03.06.2020 read with letter No. SSB/Secy/Sel/32/2019/3576 dated 14.10.2020;

Now, therefore, as recommended by J&K Services Selection Board and authorization for operation of waiting list conveyed by the Administrative Department vide aforementioned communication, sanction is hereby accorded to provisional appointment of **Mr. Manzoor Ahmad Raina S/o Gh. Mohi ud din Raina figuring at S.No. 2/RBA/wait** as "Urdu Teacher" in District Cadre **Budgam** under SRO-202 of 2015 dated 30.06.2015 as amended vide S.O. 194 dated 17.06.2020 in the Pay Level 5 (Rs. 29,200-92,300/-), as admissible under SRO-193 of 2018, dated 24.04.2018.

The conditions of probation, pay and allowances and fixation of initial tenure of the appointees shall be governed by Jammu & Kashmir Probationer (Condition of Service, Pay & Allowances) and Fixation of Tenure Rules 2020 issued vide S.O. 192 of 2020 dated 17.06.2020 read with Government Order No. 654-JK (GAD) of 2020 dated 19.06.2020.

The appointee shall report to Chief Education Officer Budgam within a period of 21 days from the date of issuance of this appointment order and shall be allowed to join only after production/submission of following documents/certificates in original to be verified subsequently:

- i. *Academic Qualification Certificates*
- ii. *Date of Birth certificate.*
- iii. *Permanent resident certificate*
- iv. *Health certificate from the concerned Chief Medical Officer of the District*
- v. *Discharge certificate from the Institution attending/last attended*
- vi. *Certificate from the concerned authority to the effect that no loan under-Self Employment Scheme has been taken by the concerned candidates.*
- vii. *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*

The appointment of the candidates shall be subject to following conditions:-

(a) That he shall give an undertaking in the shape of an affidavit duly attested by 1st Class Judicial Magistrate to the effect that:-

- i. *In case, at any stage, it emerges that the certificates/any relevant document furnished/produced by the appointee is/are fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.*
- ii. *in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by concerned Chief Education Officer, his/her appointment shall itself stand cancelled ab-initio and he/she shall have no claim to his/her appointment.*

(b) The salary of the appointee shall not be drawn and disbursed to him, unless a satisfactory report in respect of (i) & (ii) above are received in his/her favour.

(c) In case of failure to join within stipulated time period of 21 days, the appointment shall be deemed to have been cancelled abinitio without any further notice in terms of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated 04.12.2019.

(d) The appointee shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.

(e) The appointment shall be subject to the final outcome of the cases/writ petition, if any, pending before any Hon'ble Court which may not be immediately within the knowledge of this directorate.

The inter-se seniority of the appointee in the particular grade/service shall be fixed in terms of Rule 24 of CCA Rules, 1956.


