Whereas, the Administrative Department vide letter No. Edu-I/05/2015 dated 02.02.2015 forwarded the list of 263 candidates selected as Teachers for District Cadre Kupwara pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/14/3684-89 dated 30.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department vide letter No. Edu-I/05/2015 dated 20.10.2015 forwarded SSB's communication No. SSB/Sel/Secy/2015/10161-63 dated 01.10.2015 and Order No. 470-SSB of 2015 dated 08.10.2015 wherein the selection in respect of **Khalid Mehmood Jatla S/o Mohammad Shafi Jatla** figuring at **S.No. 01/Wait** under **ST Category** against item No. 442 (06 of 2013) has been released for further appropriate action and selection of **Farhat Aziz S/o Aziz ul Rahman R/o Haftrada Handwara Kupwara** figuring at **S.No. 3 under ST Category** (Item 306 of Notification 03 of 2012) has been cancelled/withdrawn abinitio;

Whereas, due to cancellation of recommendation of the above named candidate, **Mr. Tanzeel Ahmad S/o Zaffar Iqbal R/o Amroyee Karnah Kupwara** figuring at **S.No.1/Wait** under **ST Category** against Item No. Item 306 of Notification 03 of 2012 makes it to the selection zone in light of the Secretary SSB's communication No. SSB/Sel/Secy/9949-50 dated 24.09.2015 wherein it has been conveyed that "*in case a post gets accrued due to cancellation of a slot under a particular item, wait list can be operated against that slot under the said category provided the list has got validity of one year period*".

Whereas, the Administrative Department vide another communication No. Edu-I/05/2015 dated 30.10.2015 forwarded SSB's letter No. SSB/Sel/Secy/2015/11611-13 dated 28.10.2015 whereunder the selection in respect of **Qulsum Mushtaq D/o Mushtaq Ahmad Badana** figuring at **S.No. 02/Wait** under **ST Category** against item No. 462 (05 of 2013), has been released, who makes it to the selection zone as **two** slots under **ST Category** were available for operation of wait list against the same item;

Whereas, the Administrative Department vide letter No. Edu-I/287/2015, dated 24.09.2015 has conveyed instructions for operating wait list against the slots which became available due to non-joining of selectees;

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 advised to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format from the appointee with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed)
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department, all the **Three (03)** selectees furnished their undertakings on the devised format duly attested by the 1st Class Magistrate in the Directorate of School Education Kashmir for favour of further necessary action in response to DSEK's notification No. DSEK/Estt/III/B-Trs/SSB/Sel/66974-77 dated 23.11.2015;

Now, therefore, in pursuance to the aforementioned communications of SSB/Administrative Department, sanction is hereby accorded to the provisional appointment of **Three candidates** (whose full particulars are reproduced below) as **Teacher** in District Cadre **Kupwara** against the available slots under **ST** Category in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the Chief Education Officer, Kupwara by or before **17th December, 2015** for further posting.

The Chief Education Officer, Kupwara shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment orders of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
