Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas, the Administrative Department vide communication No. Edu-I/401/2015 dated 20.10.2015 has forwarded SSB's Order No. 465-SSB of 2015, dated 05.10.2015, Order No. 466-SSB of 2015, dated 05.10.2015 and letter No. SSB/Secy/Sel/2015/10433 dated 07.10.2015;

Whereas, vide SSB's Order No. 465-SSB of 2015, dated 05.10.2015, the selection in respect of Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla has been released with some change in merit position owing to his M.Phil from CMJ University;

Whereas, the said degree (M.Phil) is not coming under the purview of Govt. order No. 252-HE of 2012 dated 30.05.2012, as such Two points from his overall merit were deducted. Consequently, **Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla** shall now move from **S.No. 43/RBA of Item 447 (05 of 2013)** to **S.No. 28** under RBA Category (Item 401 of Notification 06 of 2013) with revised merit position of **61.0880**

Whereas, the Administrative Department in their earlier communication No. Edu-I/286/2012 dated: 05.09.2012 conveyed guidelines to issue the provisional appointment orders in favour of the selectees after obtaining the undertaking on the devised format with the following explicit conditions:-

The salary in favour of the selected candidates is only drawn:-

- After receiving the satisfactory report of their character and antecedents/verification from the concerned quarter;
- After receiving the satisfactory verification of qualification certificates/date of birth certificate/category certificate;
- The appointee shall furnish an undertaking (as per Annexure) duly attested by the judicial Magistrate (Copy enclosed).
- If on verification the certificates produced by the appointee are proved fake/forged, the appointment order shall be deemed as cancelled abinitio and criminal proceeding shall be initiated against the candidates.

Whereas, in light of above instructions of the Administrative Department, **Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla** furnished his undertaking on the devised format duly attested by the 1st Class Magistrate alongwith original testimonials in response to this office notification No. Estt-III/B-Trs/67022-25 dated 30.11.2015;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Waheed Ahmad Khan S/o Lt. Amir-ullah Khan R/o Azadpora Boniyar, Baramulla** as Teacher District Cadre

Baramulla against the available slot in RBA category in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to the Chief Education Officer, Baramulla by or before **17th December, 2015** for further posting.

The Chief Education Officer, Baramulla shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and **no salary** till issuance of such orders shall be drawn.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
