Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015 followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, Chief Education Officer Baramulla vide communication No. CEO/Bla/Estt/Tr/30389 dated 10.12.2015 and No. CEO/Bla/Estt/Tr/30711 dated 16.12.2015 has intimated that **Two (02)** candidates namely **Showket Ahmad Tantray S/o Abdul Rasheed Tantray R/o Rebon Rafiabab Teh Rohama District Baramulla**, and **Javeed Ahmad Lone S/o Manzoor Ahmad Lone R/o Wadoora Payeen Sopore, District Baramulla** (whose full particulars are reflected below) have shown reluctance in joining the Department as Teacher and has forwarded undertakings of these **Two(02)** candidates duly attested by 1st Class Judicial Magistrate to the effect that they have no objection if the next in merit candidates are considered against their posts;
