Whereas Mtr. Zamrooda who is a resident of District Srinagar was appointed as Teacher in District Cadre Srinagar on 29/10/1991;

Whereas Mtr. Zamrooda remained posted in Zone Ganderbal when bifurcation of districts took place in the year 2006 and new districts were carved out from the erstwhile districts, which included creation of District Ganderbal out of District Srinagar;

Whereas Mtr. Zamrooda submitted a representation stating therein that being a resident of District Cadre Srinagar and having been appointed against the district cadre Srinagar, she may be transferred/adjusted in District Srinagar;

Whereas this office took-up the issue with regard to transfer/adjustment of officials who have been appointed against district cadre posts in the erstwhile districts and are posted in newly created district and vice-versa with the Adm. Department;

Whereas Administrative Department vide No. Edu-I/222/2012 dated 26-06-2014 communicated that.....

"...I am directed to refer your letter No. Estt/III/B-Trs/100/2014/ID/Gbl/Sgr/85 dated 08-03-2014 regarding the captioned subject and to inform you that as per the instructions of GAD....."

"...Accordingly, you are requested to go ahead in the instant case as per the above instructions under intimation to this Department"....

Whereas the General Adm Department vide O.M No.GAD (Adm) 65/2012-I dated 10/7/2012 conveyed that such of the cases may be decided on the basis of domicile factor i.e. if an official has been/is residing within the territorial jurisdiction of the newly created district, he/she shall be treated as part of the district cadre of the newly created district and similarly, if an employee has/ is residing within the left over territorial jurisdiction of the old(after carving out of new district), he/she shall be treated as part of the district cadre of erstwhile/old district.

Now therefore, in view of the above, sanction is hereby accorded to the transfer of Mtr. Zamrooda, Teacher to District Srinagar. The lady teacher shall get herself properly relieved from CEO, Ganderbal.

The CEO, Srinagar shall post the lady teacher in her domicile Zone against clear vacancy without involving any chain of transfers

It shall be also ensured that the lady teacher is holding genuine appointment on substantive basis and her salary shall be drawn after satisfying veracity of related documents including 1st appointment order, service book and LPC.
