**Subject:-** Selection of the candidates for the post of Teacher District Cadre Baramulla in pursuance to the advertised Notification No's 03 of 2012, 02 of 2013, 05 of 2013 and 06 of 2013 (Item No's 256, 447 & 401) and **Cancellation** of Provisional Appointment thereof.

Whereas, the Administrative Department vide letter No. Edu-I/401/2014 dated 02.02.2015 forwarded the list of 800 candidates selected as Teachers for District Cadre Baramulla pursuant to the selection made by the J&K Services Selection Board, Srinagar vide No. SSB/Sel/Secy/2014/2955-61 dated 19.12.2014 and advised to issue appointment orders only after authentication / verification of all original certificates/character antecedents / total marks obtained from original certificates and also after authentication of category certificates from the competent authority in favour of such candidates who stand selected under reserved categories;

Whereas vide this office Notification No. DSEK/Estt/III/B-Trs/05/2015/Sel-Bla/4567-68 dated 05.03.2015 followed by many such notifications published from time to time, these selectees were advised to submit their undertakings on the devised format and accordingly provisional appointment orders were issued in their favour;

Whereas, Chief Education Officer Baramulla vide communication No. Estt/Tr/Bla/7738 dated 02.06.2015 intimated that **Fifty (50)** candidates have failed to join the Department in the stipulated time period;

Whereas, vide this office notification No. Estt-III/B-Trs/05/2015/Baramulla/65228-32 dated 23.06.2015, these candidates (who failed to join the department) were given final opportunity through Print Media to join the department within **Seven days** from the date of publication of this notification, **failing which it shall be presumed that they are not interested to join the department and the resultant slots shall be filled from the wait list under respective items/categories.**

Whereas, **Eight (08)** candidates (detailed below) who were provisionally appointed as Teachers in District Cadre Baramulla vide this office Order No.877-DSEK of 2015 Dated: 01.04.2015 also failed to join the Department and have not shown any response to the final notice served to them through Print Media;

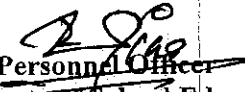
