- VIII) An affidavit duly executed before 1<sup>st</sup> Class Magistrate, to the effect that there is no Court case, investigation whatsoever nature pending before the Department or any investigating agency against the official(s).
- IX) Up-dated service verification certificate of each official.
- X) Superior claim vis-à-vis inter-se-seniority of the officials for re-determination of seniority in the cadre of Senior Assistant, if any shall be submitted to this Directorate within a period of one month through proper channel.
