In case of adverse report from the CID or adverse verification reports of PRC/DOB/Qualfication certificates from the concerned issuing authorities, the order should be deemed to have been cancelled abintio and she will have no claim for salary for the period she worked and an undertaking to this effect be also obtained from her for record and reference.
