In compliance with the order dated 28-09-2016 passed by the Hon'ble Division Bench in LPA No. 156/2016 coupled with the approval of Administrative department conveyed vide communication under reference and as recommended by the committee constituted vide Order No. 472-DSEK of 2017 Dt. 16-02-2017, sanction is hereby accorded to the appointment of Mr. Muhammad Rafeeq Baba (Matric) S/o Mr. Muhammad Ramzan Baba, (deceased Class IV(Chowkidar) HS Bagh Bandipora) R/o Bandipora, District Bandipora as Class IV (Chowkidar) on compassionate grounds in the pay scale of Rs. 4440-7440 with grade pay of Rs 1300/= against the available post in HSS Arin. The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production/verification of the following certificates in original:

- 1. Age and Health certificate.
- 2. Educational qualification certificate (from recognized Board/University)
- 3. Character/ Antecedents certificate.
- 4. Date of Birth certificate.
- 5. Permanent Resident certificate.
- 6. No Loan certificates.
- 7. Affidavit to the effect that in case of adverse report from CID he will not claim for the post/salary.
- 8. Affidavit duly Sworn before Judicial Magistrate to the effect that in the event of his failure to look after the deceased's family his appointment shall be cancelled.
- If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any further notice to the appointee. The candidate be allowed to join provisionally in absence of verification of his character/antecedents from CID. However, his pay shall not be drawn and paid till the verification of his character / antecedents is received from the CID. In case of adverse report from the CID, the order will be deemed to have been cancelled & he will have no claim for his salary for the period he worked, and an undertaking to this effect be also obtained from him for record and reference.
