Before implementing the order, the Chief Education Officer, Srinagar shall ensure that the merit position as reflected in the Provisional appointment order of the candidate coincides with the qualification/marks certificates of the appointee and fulfilling of all the terms and conditions as laid down in their provisional appointment orders.

The inter-se seniority of the appointee in the particular grade/service shall be fixed giving due consideration to their inter-se merit in the selection in terms of Rule 24 of CCA Rules, 1956 and monetary benefit shall accrue to the appointee from the date he/she assumed the post physically.

The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009 and shall be on probation for a period of Two years.


This order is issued without prejudice to any writ petition/suit, if any, pending/subjudice before the Hon'ble Court or any other Court of law.
