- That the Chief Education Officer / Drawing and disbursing officer concerned will verify the particulars of each official with reference to his original services records before allowing (In-Situ) promotion benefit and he shall be personally responsible for correctness of the particulars of employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and the case referred to this Directorate for further orders/ clarification.
- That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in 4(K) of SRO-14, Dated 15.01.1996.
- That the incumbents were not under suspension or contemplated in any charge or charge sheeted under classification Control and Appeal Rules 1996 or any other rules and his/her work and behaviour has remained satisfactory.
- That the present promotion In-Situ shall not change/ affect the existing designation/ seniority/ duties of the employees.
- That the benefit of the promotion in-Situ shall not be applicable, if the official has earlier foregone regular / functional promotion or will forego functional promotion in future.
- That the work and behaviour of the officials has remained satisfactory during the preceding 03 (three) years.
- That before implementing the order, the concerned CEO shall ensure that the employees are holding substantive appointment and his/ her appointment is genuine, before endorsing this order to sub-office for implementation.
- That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any employee.
- In-case, if it has been found that the time bound promotion has been sanctioned in favour un-regularized Migrant substantive/ contractual by virtue of this order, the same should not be given effect.
- Consequent upon grant of HSP's pay & shall be regulated strictly in accordance to the provisions laid down in SRO-14 and SRO-94 dated 15-04-2011 and Govt Order No.07-F and Govt order No.08-F dated.18/01/2011 read with SRO-42 dated.02/02/2011 and govt Order No.238-F of 2 dated.30.09.2011 in addition rules 2.43 of F.C Vol-I be also implemented while Implementation of the (In-Situ) promotion order.
- It shall be personal responsibility of the concerned Chief Education Officers to verify the particulars of each employee and observance of all formalities and conditions mentioned herein above and the DDO's concerned shall give effect/ draw the arrears on account of time bound promotion after getting the entries to this effect recorded in the service book, duly countersigned by the Concerned Chief Education Officers.
- The In-situ promotion in respect of S.No. 04 namely Balbir Kour I/c HA Zeo Chamkoote is released subject to producing of affidavit before DDO by the official duly attested by the Judicial Magistrate to the effect that in the event of her confirmation as Sr. Assistant, recovery of excess pay shall be made in lump sum.

Sanction is hereby accorded to the grant of promotion IN-SITU to the Higher Standard Pay Scale in terms of J&K Civil Services (Higher Standard Pay Scale Scheme) Rules 1996 issued by J&K Government vide SRO-14 Dated 15/01/1996 in favour of **206 (Two hundred & Six)**, Masters/ General Line teachers/RRT teachers of Kashmir Division, in the corresponding pay scale / pay band/ grade pay as shown against each in the annexure to this order, on notional basis with monetary benefit from **01/04/2014** in respect of those officials in whose favour it was due prior to **01/04/2014, in terms of rules 2.43 of Financial Code Vol-I** .

The District Wise details of teaching officials in whose favour of In-Situ promotion has been granted/ released are shown in the Annexure to this order as per details given below:-

The promotion IN-SITU to the Higher Standard Pay Scale in favour of teaching officials, whose detailed particulars are indicated in the annexure, is granted /released **subject to the fulfilment of the following conditions:-**

1. That the Chief Education Officer/ Drawing & Disbursing Officer concerned will verify the particulars of each official with reference to his /her original service records before allowing (IN-SITU) promotion benefit and he shall be personally responsible for correctness of the particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and such case shall be referred to this Directorate for further orders / clarification;
2. That the RRT has completed required spell of **05-years** continuous/satisfactory honorarium service.
3. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in rules 4(K) of SRO-14, Dated.15.01.1996.
4. That the incumbent was not under suspension or contemplated in any charge or charge-sheeted under Classification Control and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory ;
5. That the present promotion IN-SITU shall not change/affect the existing designation/ seniority/duties of the employee,
6. That the benefit of the promotion in-situ shall not be applicable, if the official has earlier foregone regular /functional promotion or will forego his functional promotion in future.
7. That before implementing the order, the concerned CEO shall ensure that the employee is holding substantive appointment and his / her 1st appointment order/ initial engagement/regularization is genuine, before endorsing this Order to sub-office for implementation.
8. That no time bound promotion has been accorded by the concerned CEO at his own in favour of any teaching personnel and none of the official has received this benefit so far.
9. Consequent upon grant of HSPS their pay fixation and pay/pension arrears admissible from the dates the HSPSS has/have granted shall be regulated strictly in accordance to the provisions laid down in SRO-93 and SRO 94 Dated 15/04/2009 and Govt. Order No. 07-F and Govt. Order No. 08-F Dated 18/01/2011 read with SRO 42 Dated 02/02/2011 and Govt. Order No. 238-F of 2011 Dated 30/09/2011. In addition rule 2.43 of F.C. Vol-I be also implemented while implementation of the (in-SITU) promotion order.

10. The CEO concerned shall allow the benefit of IN-SITU promotion in respect of teaching personnel's only after verification of their service bio-data with original documents viz Service Book, engagement/regularization order, qualification certificate and after ensuring that the initial engagement /regularization order of these RRTs have been issued by the competent authority.
11. The In-Situ promotion in respect of teaching officials, are released subject to upto date verification are got recorded in their service book by the DDO, before given the effect.
12. **The DDO's concerned will personally verify the original service records of RRT teachers and ensure that :-**
- The RRT's have completed five years honorarium service on the date indicated against each in the annexure to the order and have not availed any kind of leave whatsoever which does not count for service benefits for regularization in terms of Government Order No. 549-Edu of 2005 Dated 22/08/2005.
 - That the CEOs before implementing/endorsing the order shall once again re-verify the due date of regularization of each RRT after going through service records pertaining to the honorarium service as ReT.
 - That the RRT's were not on rolls of any institution/University during the honorarium service/ after regularization service and have not acquired any higher qualification. In case, if it has been detected while verifying the service records, that any of the RRT have acquired higher qualification during honorarium/regularization service, the order in favour of such RRT should not be endorsed by the CEO to the concerned DDO unless fresh orders are sought from this Directorate in respect of such cases.
 - That the RRT's have not been allowed higher scale in terms of SRO-225 of 2005 on acquiring graduation during honorarium service as ReT, if detected, the matter should be brought to the notice of this Directorate for seeking clarification/instructions and the Time Bound Promotion should not be released in favour of such an incumbent.
 - That the CEO will personally seek authentication of certificates both from the Distance Mode or Regular Mode from the issuing authorities.
 - That the CEO concerned will ensure/satisfy himself that the particulars of RRT are correct according to the documents and the initial engagement as ReT/Regularization of each incumbent has been made by the competent authority and are genuine/correct before endorsing this Order among the Drawing and Disbursing Officers for its implementation.
 - The Time Bound benefit shall not be absolute if at any stage it is found that the Degree certificates accounted for are fake or have been obtained through tuck shops/un-recognized Universities/Institutions, the benefit shall be cancelled abinitio with costs.
 - That the Time Bound cases are not against any Court direction/instructions given by the Hon'ble Court;
 - The CEO will be personally responsible for the genuineness, legality and eligibility of the concerned employees viz-a-viz their initial engagement/regularization, their degrees from the Recognized Universities and Time Bound Promotion.


