- 2. In case any variation is noticed in the particulars of the retired official, the benefit of the in-situ promotion shall not be released and the case be referred to this Directorate for further orders / clarification;
- 3. that the incumbent has completed required spell of 09/18/27-years satisfactorily without any interruption as defined in Rule 4(k) of SRO14 Dated 15/01/1996;
- that the incumbent was not under suspension or contemplated in any charge or charge-sheeted under Classification Control and Appeal Rules 1956 or any other rules and his work and behavior has remained satisfactory;
