Whereas, Chief Education Officer Pulwama vide letter No: CEO/PUL/NT/20/287/704 Dated: 04/11/2020 submitted the report of BHSS Ladhoo regarding unauthorized absence of Mr. Musaib Mushtaq Lab. Bearer BHSS Ladhoo; and

Whereas, pursuant to the report submitted by CEO/DDO concerned, this Directorate vide letter No: DSEK/Estt/III/B-Trs/MZ/58/20/28 Dated: 12/01/21 served Show Cause Notice to the above official; and

Whereas, Chief Education Officer Pulwama vide letter No: CEO/PUL/NT/21/36/363 Dated: 08/02/2021 informed that the Show Cause Notice has been received by one of the family member of the absentee and submitted a report in respect of the official furnished by Station House Officer Police Station Khrew; and

Whereas, the Chief Education Officer Pulwama, vide this Directorate letter No: DSEK/Estt/III/B-Trs/MZ/58/020/870 Dated: 26/04/2021, was asked to take necessary action in light of the rules governing the subject, after obtaining latest status/report from the concerned Police Station; and

Whereas, in the meanwhile Senior Superintendent of Police for SPL DG, CID J&K vide letter No: CID/Tech/PA/21/846 Dated: 10/07/2021, intimated that the above official who went missing on 17/10/2020 has joined proscribed terrorist outfit on the same date and is involved in case FIR No.64/2020 u/s 18, 20, 38 ULPA Act.

Therefore, in view of the above, Mr. Musaib Mushtaq Lab. Bearer BHSS Ladoo Pulwama is hereby placed under suspension with immediate effect.


