Subject: Placement of Senior Assistants/Incharge Senior Assistants as I/C Head Assistants in their own pay and grade on stop-gap arrangement.

For smooth functioning of the Departmental work the **20 (Twenty)** Senior Assistants/I/C Senior Assistants named in the annexure to this order are hereby allowed to hold the charge of Head Assistants temporarily, purely as stop-gap arrangements, which shall not confer any claim/benefit or preferential right to them for promotion to the post of Head Assistants.

The temporary placement of the Senior Assistants to the posts of I/C Head Assistants shall be subject to the fulfilment of the following conditions:-

- i. That the particulars as shown against the officials in the Annexure are found correct on verification by the concerned Chief Education officer/Drawing and Disbursing Officers, who shall ensure that there, is no variation/discrepancies in the particulars/bio-data. If any variation/discrepancy is found on verification by the respective Chief Education Officers/Drawing and Disbursing Officers that shall be reported to the Directorate for clarification, in case if any variation/discrepancy is detected shall not be give the effect of the placement or relieved until clarification is received from this Directorate.
- ii. This order shall not be implemented in respect of the officials who are under suspension/involved in any fake appointment or other scandal or in whose case disciplinary proceedings are pending in Vigilance/Crime Branch or any other investigating agency and whose work and conduct is not certified by the respective offer as satisfactory.
- iii. This order shall be without pre-judice to the superior claims, if any, of others or to the final outcome of the cases if any, sub-judice in any Court.
- iv. The officials placed against the posts are required to join their new assignments within a period of **10 days** from the date of issue of their adjustment order which is being issued separately.
- v. That the officials placed against the posts are not under any Court proceedings.


