10. If on the verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

In case the appointee fails to join or fails to produce the requisite certificates within 21 days from the date of issue of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence/anticipation of verification of her character/antecedents report from the CID/ verification report of PRC/Date of Birth and qualification certificate. In case of adverse report from the CID or adverse verification reports of PRC/DOB/Qualification certificates from the concerned issuing authorities, the order should be deemed to have been cancelled ab-initio and she will have no claim for salary for the period she worked and an undertaking to this effect be also obtained from her for record and reference.
