As approved by the Departmental Committee constituted vide this Office Order No. 1172-DSEK of 2017 Dated 16/02/2017, sanction is hereby accorded to the Compassionate appointment of Mtr. **Ridwana Ridhu (B.Sc.)** Date of Birth **15/03/1992** D/o Mohammad Ramzan Hajam & (Sister of Mtr. Ruby Jan deceased Teacher Middle School Halan, Zone Verinag who died in harness on 04/06/2010) R/o **Thaman Koot, Teshil Dooru District Anantnag as Class-IV (Laboratory Bearer)** against the identified vacant post in High School, Sadiwara, District Anantnag in the pay scale of Rs.4440-7440 with grade pay of Rs.1300/- The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production /verification of the following certificates in original:

1. Age and health certificate.
2. Academic qualification certificates (from recognized Board/University).
3. Permanent Residence Certificate.
4. No Loan certificate from DIC/Employment and Counseling Centre;
5. Character/ Antecedents verification certificate from IGP, CID.
6. Affidavit to the effect that in case of adverse report from CID she will not claim for the post/salary.
7. Affidavit duly sworn before Judicial Magistrate to the effect that in the event of her failure to look after the family of the deceased her appointment shall be cancelled.
8. Fresh Affidavits of all family members surrendering the claim in favour of the appointee (duly sworn before 1st Class Magistrate);
9. Fresh affidavits of appointee to the effect that he shall maintain the dependents of the deceased (duly sworn before 1st Class Magistrate).
10. If on the verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.
11. The appointee shall be governed under new pension scheme as per SRO 400 of 2009 Dated 24/12/2009.


In case the appointee fails to join or fails to produce the requisite certificates within **21 days** from the date of issue of this order, the order will cease to operate without any notice to the appointee. The candidate be allowed to join provisionally in absence/anticipation of verification of her character/antecedents report from the CID/ verification report of PRC/Date of Birth and qualification certificate. In case of adverse report from the CID or adverse verification reports of PRC/DOB/Qualification certificates from the concerned issuing authorities, the order should be deemed to have been cancelled ab-initio and she will have no claim for salary for the period she worked and an undertaking to this effect be also obtained from her for record and reference.
