Subject:- Grant of Promotion IN-SITU of Higher Standard pay scale.

ORDER NO:- 48/16 (Acctts)-DSEK OF 2018

DATED:- 15 / 09 / 2018

Sanction is hereby accorded to the grant of promotion In-Situ to the Higher standard pay scale in terms of J&K Civil Services (Higher Standard Pay Scheme) Rules 1996 issued by J&K Government vide SRO-14 dated, 15.01.1996 in favour of **82** teaching official (**Masters/General Line teachers**) in the pay band with grade pay from the date as indicated against each in the Annexure to this order, However the monetary benefit on account of In-Situ promotion shall be restricted to maximum of three years in terms of rule 2.43 of Financial Code Vol-I.

The In-Situ promotion arrears of Officials shall not be drawn till additional funds for the specific purpose are released by the Competent authority (except retired Officials) for which the concerned DDO's/CEO's shall figure out the provision and submit the requisition accordingly in consolidated manner to the Directorate for adopted Budget 2018-19. Deviation if any shall warrant strict disciplinary action against DDO concerned

The promotion IN-SITU to the Higher Standard Pay Scale in favour of teaching officials, is granted /released subject to the fulfilment of the following conditions:-

1. That the Chief Education Officer/ Drawing & Disbursing Officer concerned will verify the particulars of each official with reference to his /her original service records before allowing (IN-SITU) promotion benefit and he/she shall be personally responsible for correctness of particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of in-situ promotion shall not be released and such cases shall be referred to this Directorate for further orders / clarification;
2. That the incumbents have completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in Rule 4(k) of SRO-14 dated, 15.01.1996;
3. That the incumbent was not under suspension or contemplated in any charge or charge sheeted under Classification, Control and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory;
4. That the present promotion In-Situ shall not change / affect the existing designation / seniority/ duties of the employees;
5. That the benefit of the promotion In-Situ shall not be applicable, if the official who has earlier foregone regular/functional promotion or will forego his functional promotion in future;
6. That before implementing the order, the concerned CEO shall ensure that the employees are holding genuine appointment on substantive basis in the department, before endorsing this order to sub-Offices for implementation;
7. That no time bound promotion has been accorded by the DDO/CEO at his own level in favour of any official and none of the official has received this benefit so far.
8. **In case, if it has been found that the time bound promotion has been sanctioned in favour of RRT teacher by virtue of this order, the same should not be given effect as the time bound sanction of RRTs will be considered separately.**
9. Consequently upon grant of HSPS, their pay fixation and pay/pension arrears admissible from the date the HSPS are have been granted shall be regulated strictly in accordance to the provisions laid down in SRO-93 dated, 15.04.2009 and Govt order No.07-F and Govt Order No.08-F dated, 18.01.2011 read with SRO-42 dated, 02/02/2011, Govt Order No.238-F of 2011 dated, 30.09.2011 and SRO-193 dated, 24.04.2018;
10. The DDO/CEO concerned shall allow the benefit of in-Situ promotion in respect of erstwhile FAT (Migrant) teachers only after verification their service bio-data with original documents viz; service book, appointment order, qualification certificate and regularization order of the competent authority;
11. The officials in whose favour In-Situ promotion has been released have been appointed / promoted to the present status by competent authority.
12. That recovery of excess pay and allowance, if any, pointed out shall be attended on priority, while payment of arrears on a/c of In-Situ promotion.






