Whereas, the Administrative Department vide letter No. Edu-I/443/2016 dated 04/01/2017 has forwarded list of **ten (10)** candidates selected as Jr. Assistants, **(02)** candidates under **Item No. 911, (RBA 02)** of District cadre **Ganderbal**, **(05)** candidates under **item No. 902 (OM 04, RBA 01)** of District cadre **Bandipora** and **(03)** candidates under **item No. 899 (OM 01, RBA 02)** of District cadre **Anantnag**, issued by the Secretary, Service Selection Board, J&K Jammu bearing No. SSB/Secy/Sel/ 2016/ 19529-35 dated 31/08/2016, No. SSB/Secy/Sel/2016/19536-42 dated 31/08/2016, No. Secy/Sel/2016/19550-55 dated 31/08/2016 and No. Secy/Sel/2016/ 20739-42 dated 4/01/2016 for District **Ganderbal, Bandipora and Anantnag** and instructed to issue appointment orders after checking/verifying of the requisite documents/ testimonials;

Whereas, the select list was notified in press through Information Department vide Notification Nos. DSEK/NT/SSB/JA/529/2017/All/288 dated 04/02/2017, appeared in press through Information Department on 08/02/2017, the selectees except Mr. Masroof Ahmad Bhat S/O Saif Ud Din Bhat figuring at **S.No.01** under **(RBA)** category in District Bandipora in whose favour recommendations was kept with held, were directed to deposit their original documents/undertaking on the devised format in the Directorate within **(10)** days from the date of publishing of the Notification in press and in response to the said Notification only **(4)** candidates have submitted their documents and in whose favour appointment order is being issued.

Whereas, in the meantime the withhold recommendations in favour of Masroof Ahmad Bhat S/O Saif Ud Din Bhat figuring at S.No. 01 under RBA category in District Cadre Bandipora in the main select was released by the SSB vide No. SSB/Sel/Secy/ 2016/20100-102 dated 16/11/2016, conveyed by the Administrative Department vide No. Edu-I/444/2016 dated 06/02/2017;

Whereas, the candidates who failed to submit their required documents and Mr. Masroof Ahmad Bhat S/O Saif Ud Din Bhat figuring at **S.No. 01 under RBA category** in District cadre Bandipora in whose favour withheld recommendations, has been released now, has given one more opportunity to deposit their required documents /certificates in original as well as self attested within 07 days from the date of publication of Notification in press;

Whereas, in response to this final Notification No. DSEK/NT/SSRB/ 529/2017/617-18 dated. 03/04/2017 appeared in Daily Aftab on 10/04/2017 all candidates failed once again in submitting the required documents, except one candidate namely Masroof Ahmad Bhat existing at **S.No.06** in the Notification, submitted the required documents/testimonials in this Directorate for processing of his appointment order;

Now therefore, sanction is hereby accorded to the provisional appointment of the below named candidate selected as **Jr. Assistant** in District cadre **Bandipora**, in the pay band of Rs.5200-20200+ grade of Rs.1900/-. The full particulars/ merit points are indicated below:-

The candidate is required to report to the Chief Education Office **Bandipora** within (10) days from the date of issuance of this Order, for further posting against the available vacancy in needy institution, on his own risk and responsibility till the verification/ authentication of all relevant documents/ Certificate are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009 dated 24.12.2009**.

The appointees shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Bandipora** who shall be required to get these certificates verified/ authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic / Qualification certificates.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/ last attended
- vi. Certificates from District Industries Centre/ Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- viii. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

**The salary of the appointees shall not be drawn and disbursed unless;**

- Satisfactory report about his/her character and antecedents is received from **Inspector General of Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his/her appointment as **Jr. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- The **Chief Education Officer, Bandipora** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/ abinitio.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Bandipora** in any case.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
