Subject:- Tentative seniority list of Masters.

Notification

Whereas, the tentative seniority list of Masters was circulated vide Notification No. DSEK/ZEO-HM/1615 Dated 26/05/2014 for inviting objections and a large number of objections were received which were incorporated in the said list at appropriate place(s);

Whereas, the final seniority list of Masters whose date of promotion was falling upto 2013 was circulated vide Notification No. DSEK/ZEO-HM/615 Dated 14/6/2014, which was kept available on the official **website** of Directorate of School Education, Kashmir.

Whereas, on the basis of strict seniority/eligibility **70-Masters** were placed as Incharge Headmasters vide Order No. 2767-DSEK of 2015 Dated 18/11/2015 and Order No. 923-DSEK of 2016 Dated 30/05/2016.

Whereas, after a gap of more than a year more representations/claims were received for updation of particulars in the final seniority list and some Masters even represented with plea that their names do not figure in the list;

Whereas, after examination of particulars of such incumbents as per their representations alongwith of such drop-outs as mentioned above have been incorporated in the revised list at appropriate place(s);

Now, therefore, the updated seniority list of Masters is hereby issued the details of which available on the official website (**www.dsek.nic.in**) for objection within **31-days** (in view of prevailing circumstances). The

Chief Education Officers shall verify the particulars of enlisted Masters and return the seniority list after processing objection/correction (if any) received from genuine candidates for necessary corrections highlighting the particulars requiring such corrections with the following certificates for finalization:-

- i. that the particulars recorded against each in the updated list have been verified and found correct;
- ii. that the official is holding genuine appointment on substantive basis;
- iii. that the integrity of the official(s) is beyond doubt and no proceeding are pending in any investigating agency against any Master;
- iv. that no Master has been left out from the list.


In case of no objections, is received the list shall be declared as final and so acted upon for its operation, without further notice.
