Whereas, the Administrative Department vide letter No. Edu-I/15/2017 dated.20/03/2017, has forwarded list of six **(06)** candidates selected as **Junior Stenographer of Divisional Cadre Kashmir (OM 05, OSC 01)** by the Secretary J&K services Selection Board vide No. SSB/Secy/Sel/2017/201-207 dated 06/01/2017 & No. SSB/Secy/Sel/2017/1694 dated 03/02/2017 respectively;

Whereas, the recommendation of **(01)** selected candidate namely Ab Rashid Dar S/O. Ab Majid Dar R/O. Mumin Abad Lane No. 9 Batamaloo Srinagar, **(OM)** has been kept withheld by the Services Selection Board and is subject to verification of PG (DCA);

Whereas, recommendations kept withheld in respect of one selected candidate namely Wasim Fayaz S/O Fayaz Ahmad R/O Chattabal Srinagar figuring in the select list at **S.No.05 (OM)** category has been released by SSB vide their office communication No. SSB/Secy/Sel/Secy/12/17/1095-97 dated 23/01/2017;

Whereas, this office vide notification No. DSEK/NT/SSB/537/2017/All/758 dated 01/05/2017 appeared in press through Information Department on 02/05/2017, directed the selectees except Ab Rashid Dar S/O Ab Majid Dar, whose recommendation is withheld to deposit their requisite original as well as self attested certificates, (academic/ professional/additional) in this Directorate within ten **(10) days** from the date of publication of the notification in the press;

Whereas, in response to the said Notification published through information Department in press, only **02 (two)** candidates **(OM 01, OSC 01)** out of **(05)**, have deposited their requisite documents in this Directorate for processing of their appointment orders;

Now therefore, sanction is hereby accorded to the provisional appointment of the following **two (02)** candidates selected as **Junior Stenographer Divisional Cadre Kashmir**, in the pay band of Rs.9300-34800+ grade of Rs.4200/-, whose merit position as indicated in the selection is given against each:-

The candidates are required to report to Principal SIE Srinagar and Principal DIET Srinagar respectively within ten (**10**) days from the date of issuance of this order on their own risk and responsibility till the CID verification is received from the CID/Police Department.

The appointees shall be governed under New pension Scheme as notified vide **SRO-400 of 2009 dated 24/12/2009**.

The appointees shall be on probation for a period of two years and subject to production of following certificates (in original).

- ❖ Character and antecedents certificate from Inspector General of Police (CID)
- ❖ Qualification certificates / Technical qualification certificate.
- ❖ Permanent resident certificate
- ❖ Age and health certificate
- ❖ Discharge certificate from the Institution attending/ last attended
- ❖ Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee
- ❖ Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.

**The salary of the appointees shall not be drawn and disbursed unless;**

- Satisfactory report about their character and antecedents is received from **Inspector General of Police (CID) J&K** and **category certificates** (if any) from the issuing authority.
- The appointees shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointees shall have no right to claim his/her appointment as **Jr. Stenographer** and appointment as such shall be deemed to have been cancelled ab-initio.
- The appointees shall give an undertaking duly attested by the Judicial Magistrate 1st Class that they will not apply for transfer from **Kashmir Division** in any case, and in case, at any stage it emerges that the certificates/ any relevant document furnished/ produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceeding shall be initiated against the candidate.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned CEO duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate/s till formal appointment order is issued from this Directorate.

The inter-se seniority of the appointee shall be in the order in which his/her name appear in the select list furnished by the J&K Services Selection Board.

The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in ay court of competent jurisdiction.
