Subject:- Minutes of the meeting.

A meeting with Association of J&K (Un-Aided) Private School Coordination Committee Srinagar was held today on 14-01-2015 under the Chairmanship of Director School Education Kashmir in his office Chamber.

Participants:-

1. Joint Directors.
2. Personnel Officer DSEK
3. District Education Planning Officer, Srinagar.
4. Representatives / Members of Association headed by Sh. Vishen

At the outset the Director School Education Kashmir highlighted the role of education in building the nation. The participants were advised to ensure quality education in schools and follow the Government Orders / norms in letter and spirit.

The Chairman of J&K (Un-Aided) Private School Coordination Committee Srinagar highlighted their problems faced by the Private Schools in the house. The following decisions were taken to overcome such problems. After detailed discussions and to ensure the red-tapesim is discouraged.

1. Extension / Managing Body:-

All the requisite documents required in terms of SRO 123 should be attached with the file. It is further decided that upto class 8th the school management should apply for both Grant of Extension and approval of Managing Body at the same time, coterminous.

2. Joint Inspection J&K BOSE:

As discussed with the Chairman BOSE, no separate inspection shall be conducted either by DSEK for schools class 9th onwards. All inspections regarding grant of extension to affiliation / recognition to private schools for running classes beyond 8th will be conducted jointly team of officials of BOSE/School Education Department in terms of Government Order NO. 668-Edu of 2005 dated 05-10-2005.

3. Counter Sign of Discharge / Provisional Certificates and Results:-

While Counter Signing Discharge / Provisional Certificates and confirmation of results of private schools, the concerned signatories of School Education Department shall only ask for Recognition and Managing Body approvals and no other NOCs be insisted upon.

In case of under process cases the matter shall be taken up with DSEK for necessary action / directions.

4. Fire & Emergency Certificate:-

Regarding subject it was impressed upon the representatives of the Private Schools to furnish categoric fire safety certificate obtained from Fire & Emergency Department to the effect that the instant institutions has taken fire safety measure in the said schools.


