Whereas, in compliance to the judgment dated : 19/03/2015 passed by Hon'ble High Court in SWP No. 1188/2014 read with order dated : 03/10/2016 passed in contempt petition No. 919/2015 conveyed by the Administrative Department vide letter no. Edu/Legal/K/114/2015 dated 24/10/2016 the petitioner namely **Sabeena Qadir, D/O Late Ghulam Qadir Sofi, R/O Gratabal, Nawakadal, Srinagar** was provisionally appointed as General Line Teacher in District Cadre Srinagar vide this office Order No. 1535-DSEK of 2016, dated 02.11.2016 subject to the condition that her selection/appointment shall remain subject to the final outcome of LPA filed by SSB against the judgment dated 19/03/2015 and veracity of her documents determining her eligibility;

Whereas, Chief Education Officer Srinagar vide letter No. CEO/Estt/06/1575 dated 09.06.2017, furnished verification reports of her certificates/testimonials, for issuance of formal appointment order in her favour;

Whereas, vide this office letter No. DSEK/Legal/167/14/1203 dated 20.09.2017, the matter was taken up with the SSRB for intimating whether any legal recourse has been adopted for restoration of COD No. 180/2016, which stand dismissed by the Hon'ble Court vide order dated 24.05.2017;

Whereas, in response to this office letter dated 20/09/2017, the Public Law Officer, Services Selection Board, Srinagar vide letter No. SSB/S-31/2014/2253-54 dated 25/10/2017 conveyed that the matter is being taken up with the Learned Additional Advocate General, however, the formal appointment order in favour of the petitioner may be issued in present circumstances;

Now, in view of the above circumstances and verification report of certificates/testimonials furnished by Chief Education Officer Srinagar, sanction is hereby accorded to the confirmation of the provisional appointment issued in favour of **Sabeena Qadir D/o Late Gh. Qadir Sofi** vide order No. 1535-DSEK of 2016, dated: 02.11.2016, subject to the condition that the petitioner will abide by direction(s), if any, passed by the Hon'ble Court in aforementioned writ petition/LPA. The appointee shall be on probation for a period of Two (02) years, from the date of issuance of provisional appointment order in her favour.

The formal appointment order is issued subject to the fulfillment of all the terms and conditions as laid down in the provisional appointment order and seniority shall be fixed as per CCA Rules (1956) and satisfactory qualifying of probation period.

This order is issued without prejudice to any writ petition/suit if any pending /sub-judice before the Hon'ble High Court or any other court of law.
