**ORDER NO. 591 DSEK OF 2016**  
**DATED: 30 / 03 / 2016**

Whereas, Chief Education Officer, Kupwara vide letter No. Estt-III/40180 Dated 29/02/2016 has furnished the particulars of **10-Masters** belonging to District Baramulla who have working in the 3<sup>rd</sup> Zone i.e. Keran, Machal & Tangdar District Kupwara for their repatriation to District Baramulla on the completion of one year tenure in 3<sup>rd</sup> Zone;

Whereas, the Chief Education Officer, Baramulla vide this Office letter No. CEO/Bla/Tr/46685 Dated 24/03/2016 was asked to furnish the stay list of Masters working in District Baramulla;

Whereas, in order to pave-a-way for repatriation of Masters working in 3<sup>rd</sup> Zone it become necessary to shift the mature stay **15-Masters** from District Baramulla to District Kupwara.

Now, therefore, in view of the extant transfer policy, sanction is hereby accorded to the transfer of 15-Masters from District Baramulla to District Kupwara as named in **Annexure "A"** to this Order subsequently the 10-Masters from District Kupwara (3<sup>rd</sup> Zone) to District Baramulla named in the **Annexure "B"** to this Order with immediate effect. **The Masters so transferred to Zone 3<sup>rd</sup> Areas of Kupwara District shall serve there for a period of one year and shall be automatically transferred back at the end of the year.**

The transferees shall report to Chief Education Officer Baramulla/Kupwara for seeking further posting orders after getting themselves properly relieved by the Chief Education Officer, Kupwara/Baramulla.

Before implementing this order, the Chief Education Officer Baramulla/Kupwara will personally ensure that the transferees are holding genuine appointment in the Department on the substantive post and has been appointed by the competent authority and does not fall Fake/Fraud category.




