Whereas, the Administrative Department vide letter No. Edu-I/124/2016, dated. 29/04/2016, has forwarded select list of **07 (Seven) Junior Assistants, (OM=05 & RBA=02)**, of District **Budgam**, issued by the Secretary J&K Service Selection Board Jammu Vide No. SSB/ Secy/Sel/2016/3584-90 dated. 02/03/2016;

Whereas this office vide Notification No. DSEK/NT/SSB/JA/516/2016/379 M/Bud/1059-60, dated. 27/05/2016, appeared in Press through information department dated 02/06/2016. directed the selectees to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within **(10) days** from the date of publishing of the notification in the press;

Whereas, vide this office Notification No DSEK/NT/SSRB/516/2016/JA/Bud/371-M/2087. dated. 25/10/2016 appeared in Press through information department dated 31/10/2016, directed the selectees who failed to deposit their requisite original as well as self attested certificates/testimonials in this Directorate to deposit the said documents within **(07) days** from the date of publishing of the notification in the press;

Whereas, in response to the said notifications only **06 (six) selected candidates (OM=04 & RBA=02)**, have deposited their documents/testimonials in the Directorate for issuing their appointment orders;

Whereas, the provisional appointment were issued in respect of those candidates who have deposited the documents in the Directorate, vide this office order No. 1099-DSEK of 2016, dated. 22/06/2016;

Whereas, the candidate under **OM category** who has failed to deposit his documents in the Directorate despite given one more opportunity to deposit the same within **(7) days** vide notification No. DSEK/NT/SSRB/516/Jr.Asstt/Bud/371-M/2087 dated. 25/10/2016 appeared in press on 31/10/2016 has again failed to do so;

Whereas, due to non-production of documents/certificates by one candidate, the matter has been take-up with the Administrative Department for authorisation of operating of wait list vide this office letter No. DSEK/NT/SSRB/516/2016/Bud/371-M/2410, dated. 09/12/2016;

Whereas, the Administrative Department vide letter NO. Edu-I/124/2016, dated. 24/01/2017, has conveyed approval for operating waiting list against the slot which became available due to non-depositing of documents by the selected candidate;

Whereas, vide this office notification No. DSEK/NT/SSB/JA/516/2016/Bud/371 M/3584-34 dated. 13/02/2017 the candidate appearing in waiting list at S.No. 01 namely Sajad Rashid S/O Ab. Rashid R/o Kaiser Mulla Chadoora, was asked to deposit the requisite original as well as self attested certificates/testimonials in this Directorate within **(07) days** from the date of publishing of the notification in the press;

Whereas, in response to the aforementioned Notification, the said selected candidate under waiting list has deposited his documents/testimonials/undertaking in the Directorate.

Now therefore, in view of the above, sanction is hereby accorded to the provisional appointment of Sajad Rashid S/O. Ab. Rashid R/O. Kaisermulla Chadoora, as Junior Assistant in District cadre **Budgam**, in the pay band of Rs.5200-20200+ grade pay of Rs.1900/-

The candidate is required to report to the Chief Education Office **Budgam** within (21) days from the date of issuance of this Order, for further posting against the available vacancy in needy institution, on his own risk and responsibility till the verification/authentication of all relevant documents/Certificate are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as notified vide **SRO-400 of 2009 dated 24.12.2009**.

The appointees shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Budgam** who shall be required to get these certificates verified/ authenticated from the concerned issuing authorities

- i. Character and antecedents certificate from Additional Director General of Police (CID).
- ii. Academic / Qualification certificates.
- iii. Permanent resident certificate
- iv. Age and health certificate
- v. Discharge certificate from the Institution attending/ last attended
- vi. Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
- vii. Category certificates (in case of reserved categories) under SRO 294 of 21/10/2009.
- viii. Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

**The salary of the appointees shall not be drawn and disbursed unless;**

- Satisfactory report about his/her character and antecedents is received from **Inspector General of Police (CID) J&K** and genuineness/verification report for qualification/Technical Certificate/ Marks Certificates and category certificates (if any) from the issuing authority.
- Appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from the concerned **Inspector General of Police (CID) J&K**, the appointee shall have no right to claim his/her appointment as **Jr. Assistant** and appointment as such shall be deemed to have been cancelled ab-initio.
- The **Chief Education Officer, Budgam** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled/ abinitio.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Budgam** in any case.

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned Chief Education Officer duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

This order is issued without prejudice to any writ petition(s)/suit, if any, pending/sub-judice before the Hon'ble High Court or any other court of law or any order which may not be presently within the knowledge of this Directorate.
