As recommended by the committee constituted vide this office Order No. 472-DSEK of 2017 Dt. 16-02-2017, Sanction is hereby accorded to the compassionate appointment of Mr. Irshad Ahmad Shah B.A, B.Ed S/o Mohd. Shafi Shah, (deceased Class IV (Chowkidar), GMS Nunner ) R/o Nunner, Ganderbal as Class IV (Lab. Bearer) in the pay scale of Rs. 4440-7440 with grade pay of Rs 1300/= against the available post in GHS Manigam. The appointee shall be on probation for a period of two years.

**The appointee shall be allowed to join only after production/verification of the following certificates in original:**

1. Age and Health certificate.
2. Educational qualification certificate (from recognized Board/University)
3. Character/ Antecedents certificate.
4. Date of Birth certificate.
5. Permanent Resident certificate.
6. No Loan certificates.
7. Affidavit to the effect that in case of adverse report from CID he will not claim for the post/salary.
8. Affidavit duly Sworn before Judicial Magistrate to the effect that in the event of his failure to look after the deceased's family his appointment shall be cancelled.
9. If on verification , the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled abinitio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, the order will cease to operate without any further notice to the appointee. The candidate be allowed to join provisionally in absence of verification of his character/antecedents from CID. However, his pay shall not be drawn and paid till the verification of his character / antecedents is received from the CID. In case of adverse report from the CID, the order will be deemed to have been cancelled and the appointee will have no claim for salary for the period he worked, and an undertaking to this effect be also obtained from him for record and reference.
