Whereas, on the basis of feedback provided by the Chief Education Officer Baramulla, the placement order in respect of 69 (sixty nine) Class-iv employees of District Baramulla having date of 1<sup>st</sup> appointment upto 22/03/1995 to their next cadre on strict seniority, purely on temporarily basis as stop gap arrangement, was issued vide order No.2951-DSEK of 2015 dated. 18/12/2015,.

Whereas, the Chief Education Officer Baramulla vide his office letter No.CEO/Bla/NT/2015/36942 dated. 23/01/2016, has intimated that Zonal Education Officer Chandanwari, has reported that due to clerical mistake qualification of Mtr, Zahida Akhter Class-IV BMS Bijhama has shown 8<sup>th</sup> pass instead of 10<sup>th</sup> due to which her service particulars were not submitted to CEO's Office well in time.

Whereas, on perusal of the case and feedback provided by the CEO Baramulla, it reveals that the applicant as per her qualification/ seniority and criteria set by the Department in terms of SRO-308 of 2008 dated.16-10-2008 is eligible to the next cadre as I/C Lab. Assistant.

Now, therefore, In continuation to this office Order No. 2159 DSEK of 2015 Dated.18/12/2015, pending clearance by the DPC and GAD (Vig.) Sanction is accorded to the placement of Mr. Zahida Akhter, Class-iv (Orderly) whose full service particulars are give below, as Incharge Lab. Assistant in her own pay and grade purely on stop gap arrangement basis in the District Cadre Baramulla, on the same terms and conditions as laid down in the placement order issued vide No.2951-DSEK of 2015 dated.18-12-2015.
