Sanction is hereby accorded to the grant of promotion In-Situ to the Higher standard pay scale in terms of J&K Civil Services (Higher Standard Pay Scheme) Rules 1996 issued by Government vide SRO-14 dated. 15.01.1996 in favour of **22** teaching personnel's (General/ /Generals Line teachers) in the pay band with grade pay from the date as mentioned against each in the Annexure to this order, However the monetary benefits be given for last 12 months in terms of rule 2.43 of financial code Vol-I, except those officials who have retired before to 01.01.2018, who may be allowed one month monetary benefits to the In-Situ promotion.

The In Situ promotion arrears of Officials shall not be drawn till additional funds for the specific officials are released by the Competent authority (except retired Officials) for which the concerned DDO's shall figure out the provision and submit the requisition accordingly in consolidated manner to the Directorate. Deviation if any shall warrant strict disciplinary action against DDO concerned

The promotion IN-SITU to the Higher Standard Pay Scale in favour of teaching officials, mentioned /released subject to the fulfilment of the following conditions:-

1. The Chief Education Officer, Drawing & Disbursing Officer concerned will verify the particulars of each official with the original service records before allowing (IN-SITU) promotion benefit and he/she shall be personally responsible for correctness of the particulars of the employees working under him. In case any variation is noticed in the particulars of any such official, the benefit of the in-situ promotion shall not be released and such cases shall be referred to the concerned authority for further orders / clarification;

2. The concerned employees has completed required spell of 09/18/27 years as the case may be satisfactorily and without any interruption as defined in Rule 4(k) of SRO-14 dated. 15.01.1996;

3. The concerned employees was not under suspension or contemplated in any charge or charge- sheet under Classification and Appeal Rules 1956 or any other rules and his/her work and behaviour has remained satisfactory;

4. The promotion In Situ shall not change / affect the existing designation / seniority/ duties of the employees;

5. The benefit of the promotion In-Situ shall not be applicable, if the official who has earlier foregone regular /functional promotion or /all forego his functional promotion in future.

6. Before implementing the order, the concerned CEO shall ensure that the employees are holding substantive appointment in the concerned posts before endorsing this order to sub Offices for implementation;

7. The time bound promotion has been accorded by the DDO/CBO at his own in favour of any official and none of the officials has availed this benefit so far.

8. If it has been found that the time bound promotion has been sanctioned in favour of RRT by virtue of this order, the same should not be given effect as the time bound sanction of RRT will be considered separately.

9. The employees upon grant of HSEs, their pay fixation and pay/pension arrears admissible from the date the HSPs has /has not been regulated strictly in accordance to the provisions laid down in SRO 93 dated. 15.04.2009 and Govt. Order No.08 F dated. 18.01.2011 read with SRO 42 dated.02/02/2011 and Govt Order No.238 F dated. 03/06/2011

10. The concerned CEO shall allow the benefit of In-Situ promotion in respect of erstwhile FAT /Migrant teachers only in those cases where their service bio-data with original documents viz. service book, appointment order, qualification order and regularization order of the competent authority.



5. That the work and behaviour of the officials has remained satisfactory during the preceding 03 (three) years;

9. 

 2. That the CEOs before implementing/ endorsing the order shall once again re-verify the due date of regularization of each RRT after going through service records pertaining to the honorarium service as ReT.
 3. That the RRT's were not on rolls of any institution/University during the honorarium service/ after regularization service and have not acquired any higher qualification as regular. In case, if it has been detected while verifying the service records, that any of the RRT have acquired higher qualification during honorarium/ regularization service as regular, the order in favour of such RRT should not be endorsed by the CEO to the concerned DDO unless fresh orders are sought from this Directorate in respect of such cases.



