Whereas, vide this office Order No. 337 - DSEK of 2020 dated 09/09/2020 the service of the petitioner were deemed to have been terminated in terms of **Article 128 of J&KCSR Vol-I of 1956** from the date of un-authorized absence in the Department; and

Whereas, after issuance of termination order, the Chief Education Officer, Srinagar vide his communication dated **25/11/2020**, while furnishing the information regarding un-authorizedly absent employees, erroneously included the name of the said teacher and resultantly **02 show cause notices** were issued to the teacher by this Directorate vide this office No. DSEK/Estt/III/B-Trs/MZ/190/020/785 dated **19/04/2021** and No. DSEK/Estt/III/B-Trs/Mz/150/021/1121 dated **06/07/2021**(Joint Show Cause Notice): and

Whereas perusal of the records reveal that the said notices have been issued to the teacher post her termination erroneously on the basis of the misinformation furnished by Chief Education Srinagar.

Now therefore, the show cause notice issued by this office under No. DSEK/Estt/III/B-Trs/MZ/190/020/785 dated **19/04/2021** and No. DSEK/Estt/III/B-Trs/Mz/150/021/1121 dated **06/07/2021** (to the extent it pertains to Mtr. Masrat Rashid Ex-Teacher, GMS Zainakote Zone Batamaloo District Srinagar) is hereby withdrawn, abnitiio.
