Whereas, in order to ascertain the genuineness of your appointment order, the original appointment order issued by this Directorate vide No. 491-DSEK of 2009 dated 12-06-2009 and selection list issued by the J&K Service Selection Board have been verified and it has been found that your name does not exist anywhere neither in the appointment order nor in the selection list and;

Whereas, the dispatch No. CEO/Estt/Apptt/2009/9853-55 dated 06-07-2009 mentioned in your posting order has not any relevance with the original records,



Now therefore, you are given an opportunity to be heard in person in this office alongwith statement of facts and supporting documents if any, within seven days, from the date of issuance of this notice, failing which action as warranted under law, will be initiated in the matter, without any further notice.
