Approval of the Divisional Level Selection Committee, constituted vide above referred to G.O. No. 23-Edu of 2019 dated 22.01.2019, is conveyed for Appointment of **75** Grade III Teachers engaged under Sarva Shiksha Abhiyan (now Samagra Shiksha) in District Anantnag/Kulgam/ Pulwama/ Shopian, forming **Annexure** to this Order, as Grade-II Teachers. However, the appointment order thereof shall be issued by the Chief Education Officer, District Anantnag/Kulgam/ Pulwama/ Shopian, subject to the fulfillment of following conditions: -

- i) The appointment of RReTs as Teacher Grade-II shall be reckoned w.e.f. date of attaining minimum qualification (i.e. Graduation).
- ii) The Chief Education Officer, Anantnag/Kulgam/ Pulwama/ Shopian shall be personally responsible to verify genuineness/authenticity of following original testimonials before giving effect to the order of

appointment of Grade III Teachers as Grade-II Teachers in so far as release of salary is concerned:-

- a. Academic Qualification Certificate (s).
 - b. Date of Birth certificate.
 - c. Permanent Residence Certificate.
 - d. Appointment Order.
 - e. Joining Report as ReT Teacher.
 - f. Authenticated service record from the DDO/ZEO.
 - g. Regularization order as RReT.
 - h. Category Certificate in case of ST/SC/ALC/RBA candidates, if appointed under reserved category.
- iii) The appointment order as Grade-II Teacher shall be subject to the condition, *inter alia*, that in the event it is established at any stage that the certificates/documents/services records furnished by the appointee are fake/fictitious, the order of appointment as Grade-II Teacher shall be deemed to have been cancelled *ab initio*.
- iv) The DDO concerned shall ensure that the Teacher Grade III had attained minimum prescribed age at the time of appointment/engagement and had not crossed the maximum prescribed age limit.
- v) The DDO concerned, shall obtain an undertaking/ Affidavit duly attested by the Judicial Magistrate of 1st Class, from all Grade III Teachers proposed to be appointed/upgraded as Teacher Grade-II, as per the format of **Form "A"** already forwarded.
- vi) Upon the appointment of Grade III Teachers to Grade II Teachers, the post of Grade III Teachers will be restored as Grade II Teachers.
- vii) That post facto permission for enhancing the qualification in private mode as an in-service candidate is hereby accorded subject to the following conditions:
- 1) That the Grade III Teacher has availed leave under rules for the purpose that was conveyed to the DSEK at the time of regularization and same stands entered in his/her service book accordingly.
 - 2) That the leave availed by the incumbent during honorarium period or post regularization was due under rules and excess leaves, if any, availed have been accounted for at the time of regularization with costs.

- 3) That the degree has been acquired in terms of circular instructions governing the issue of improving of qualification during honorarium service.
- 4) That the degree has been acquired through recognized University/College and equivalence, wherever required, has been certified by the competent authority.
- 5) That this permission shall be deemed to be cancelled ab-initio, if at any stage, it is established that the degree(s) acquired by the Grade III Teacher is/are fake or have been obtained through tuck shops/un-recognized University/Institution or if the degree is not recognized as an equivalent degree for the benefit claimed or reaped by incumbent.
- 6) That the authenticity/genuineness of academic certificates has been ascertained/established by the CEO/DDO discreetly and the CEO/DDO shall be personally responsible for genuineness/legality and validity of the certificate.
- 7) The CEO/DDO shall ensure that the qualification has not been acquired through regular mode when candidate was on the establishment of School Education Department.




