

2. Chief Education Officer **Pulwama** for information and necessary action. In case any variation / discrepancy is detected in the particulars of **Rehbar-e-Taleem/s** so regularized, the order shall not be given effect and the same should be referred to Directorate within 15 days and no claim shall be entertained after stipulated period.
