Whereas, vide this office Order No. 328-DSEK of 2021 dated 15.06.2021, **Mtr. Manisha Bhat D/W/o Vijay Kumar Bhat R/o Bonagund Verinag Anantnag** was provisionally appointed as "Teacher" in District Cadre Anantnag under Prime Minister's Special Package for Kashmiri Migrants pursuant to her selection made by the JKSSB as conveyed by the Administrative Department's communication No. Edu-I/908/2017 dated 15.04.2021;

Whereas, after expiry of the stipulated time period of **21 days**, the Chief Education Officer Anantnag vide letter No. CEO/A/Estt-II/13747/21 dated 23.07.2021 communicated that the above named candidate has failed to join on the post of "Teacher" for which she was appointed in the Department vide Directorate's Order No. 328-DSEK of 2021 dated 15.06.2021;

Whereas, in light of the circular instructions issued by GAD vide No. 08-JK(GAD) of 2019 dated: 04/12/2019 the candidates who fails to join within a period of **Twenty one (21) days** from the date of issuance of the appointment order shall forego his/her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
