Seniority of the appointee shall be fixed as per CCA Rules (1956) and satisfactory qualifying of probation period.


This order is issued without prejudice to any writ petition/suit if any pending/sub-judice before the Hon'ble High Court or any other court of law.

Whereas, the Administrative Department vide letter No. Edu-I/908/2017 dated 15.12.2017 forwarded the selection list of **Two-hundred Twenty (220)** candidates selected as Teachers, District Cadre Shopian, Srinagar, Pulwama, Kupwara, Kulgam, Budgam, Baramulla, Bandipora and Anantnag in pursuance to Advertisement Notification No. 01 of 2012 dated 19.07.2012 (Item No's. 033, 037, 029, 025, 021, 013, 009, 005 & 001) respectively under Prime Minister's Special Package for Kashmiri Migrants (Pending Cases), for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/11258-65 dated: 06.11.2017;

Whereas, among these **220** candidates, selection in respect of **Ninety (90)** candidates has been kept withheld by SSB for want of certain clarification, leaving 130 candidates in whose favour a notification vide No.DSEK/Estt/III/B-Trs/PMP/PP/28-39 dated 04/01/2018 was issued through Information Department directing the candidates to deposit their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009;

Whereas, in response to the above notification dated 04.01.2018, **One Hundred Six (106)** candidates (Out of 130) submitted their certificates/documents in the Directorate of School Education Kashmir, within the stipulated period and **Twenty-four (24)** candidates failed to do so;

Whereas after scrutinization of documents, among others, marks variation in **10+2** was detected in respect of **Shavita Raina D/o Subhash Raina** figuring at **S.No. 176** in **District Cadre Srinagar**, which has now been rectified by SSB vide communication No. SSB/Secy/Sel/2017/696 dated 15.01.2018;

Now, therefore, in continuation to this office order No. 200-DSEK of 2018 dated 17.02.2018, sanction is hereby accorded to the provisional appointment of **Shavita Raina D/o Subhash Raina** figuring at **S.No. 176** in **District Cadre Srinagar** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the **pay scale of Rs.5200-20200 with grade pay of 2400**, admissible under SRO-93 dated 15.04.2009. The candidate is required to report to Chief Education Officer Srinagar, within **Ten (10)** days from the date of issuance of this appointment order for seeking further posting on her own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

**The provisional appointment shall be subject to the following conditions:-**

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidates shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointee shall be fixed at the places on the posts of their first appointment in that particular grade/service and the provisional appointees shall be on probation initially for a period of Two years.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.


