Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 17.04.2017 forwarded the selection list of **Two-hundred Sixty-five (265)** candidates selected as Teachers, (**203 for District Cadre Srinagar and 62 for District Cadre Baramulla**) under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No's 037 & 009 respectively;

Whereas, the Administrative Department vide communication No. Edu-I/77/2017 dated 15.12.2017 and No. Edu-I/77/2017 dated: 08.01.2018 forwarded various communications of SSB whereunder among others, selection in respect of **Vinod Koul S/o Veer Jee Koul** figuring at S.No. 19 in District Cadre Baramulla and **AMIT SARAF S/o BIHARI LAL SARAF** figuring at S.No. 55 in District Cadre Srinagar was released and were accordingly informed vide this office notification dated 08.01.2018 and notification dated 03.02.2018 to submit their requisite papers in the Directorate;

Whereas, in response to the above notifications, both the candidates submitted their papers and after scrutiny and some variation in particulars of **AMIT SARAF S/o BIHARI LAL SARAF** and **VINOD KOUL S/O VEER JEE KOUL** was detected and accordingly the SSRB vide communication No. SSB/Secy/Sel/2018/3083 dated 23.03.2018 and No. SSB's letter No. SSB/Secy/Sel/2018/2093 dated 20.02.2018 conveyed by Administrative Department vide letter No. Edu-I/77/2017 dated 16.04.2018, has issued necessary clarification/rectification;

Now, therefore, sanction is hereby accorded to the provisional appointment of **Two (02) candidates** (whose full particulars are reproduced below) as Teachers in District Cadre Srinagar/Baramulla against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the Chief Education Officer, Srinagar/Baramulla within **Twenty-one (21)** days from the date of issuance of this appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- A) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- B) The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.



The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointee shall be fixed at the places on the posts of their first appointment in that particular grade/service and the provisional appointee shall be on probation initially for a period of Two years.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.


