Nos. No. SSB/Secy/Sel/64/2019/2090-97, dated: 19/03/2019, No. SSB/Secy/Sel/63/2019/2062-68, dated. 19/03/2019, and No. SSB/Secy/Sel/62/2019/2076-82, dated: 19/03/2019 respectively, under Hon'ble Prime Minister's Special Package for Kashmiri Migrants for issuance of appointment orders in their favour after fulfilling all codal formalities and conditions as envisaged under Jammu & Kashmir Migrants (**Special Drive**) **Recruitment Rules, 2009, issued under SRO. 412 of 2009, dated 30/12/2009.**
