The appointee shall report to the Chief Education Officer Srinagar within a period of 21 days from the date of issuance of this order and shall be allowed by the Chief Education Officer Srinagar to join only on the production of the following documents/ certificates to be verified from the issuing authority subsequently:-

- i. Academic Qualification Certificate.
- ii. Age and Health Certificate.
- iii. Permanent Resident Certificate.
- iv. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- v. All other relevant documents as are required under SRO-43/1994.
- vi. No loan certificate under Self Employment Scheme from DIC concerned and Employment Department.

The salary of the appointee shall not be drawn and disbursed, unless a satisfactory report about the verification of his character and antecedents and other required certificates is received from the Inspector General of Police CID/ concerned issuing authority, to whom a references shall be made by Chief Education Officer Srinagar separately.

The appointee shall furnish an undertaking duly attested by 1<sup>st</sup> class Magistrate to the effect that in case of adverse report from CID and other concerned agencies and other certificates from issuing authorities he shall not claim any salary for the period he has worked.
