Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated 17.04.2017 and No. Edu-I/56/2017 dated: 17.04.2017 forwarded the selection list of candidates selected as Teachers, in **District Cadre Srinagar/Baramulla/Anantnag/Bandipora** under Prime Minister's Special Package for Kashmiri Migrants, for issuance of appointment orders in their favour after fulfilling all formalities and conditions as envisaged under Jammu and Kashmir Kashmiri Migrants (Special Drive) Recruitment Rules, 2009 issued under SRO-412 of 2009 pursuant to the selection made by the J&K Services Selection Board, Srinagar vide letter No. SSB/Secy/Sel/2017/1206-12 dated 25.01.2017 and No. SSB/Secy/Sel/2017/1213-20 dated 25.01.2017, and No. SSB/Sel/Secy/017/3033 dated 15.03.2017 against Notification No. 01 of 2012 dated 19.07.2012, Item No's 037, 009, 001 & 021 respectively;

Whereas, the Administrative Department vide letter No. Edu-I/77/2017 dated: 09.03.2018 and No. Edu-I/56/2017 dated 28.03.2018 forwarded SSB's communication No. SSB/Secy/Sel/Mig/Sgr/XII/12167-69 dated 24.11.2017, No. SSB/Secy/Sel/Mig/Sgr/IX/2017/12162-69 dated 24.11.2017, No. SSB/Secy/Sel/Mig/Sgr/XII/12631-33 dated 28.11.2017, No. SSB/Secy/Sel/2017/13468 dated 20.11.2017 and Order No. 664-SSB of 2017 dated 22.11.2017 whereunder selection in respect of **Four** candidates has been released which was earlier kept withheld by the SSB;

Whereas, in terms of SSB's Order 664-SSB of 2017 Dt: 22.11.2017, **Two** points of PG Degree have been deducted from overall merit of **Amit Bhat S/o Moti Lal Bhat** who was earlier figuring at **S.No. 54** and has been placed at **S.No. 79** and consequent upon S.No 55 shall now figure at S.No. 54 so on and so forth upto S.No. 79;

Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/2086-88 dated 24/05/2018, these candidates were advised to furnish a copy of their testimonials and undertakings alongwith agreements on the devised format duly attested by the 1st Class Magistrate in terms of SRO-412 of 2009 dated 31.12.2009, in the Directorate of School Education Kashmir, within a period of Ten days from the publication of the notification for issuance of provisional appointment orders in their favour;

Whereas, in response to the above notification, all the **Four (04)** candidates deposited the requisite papers in this Directorate for considering their provisional appointment order;

Whereas, vide SSB's communication No. SSB/Secy/Sel/2017/1047 dated 23.01.2018 and No. SSB/Secy/Sel/Mig/Ang/2558 dated 09.03.2018 conveyed by Administrative Department vide above referred to communication, marks variation in 12th & Graduation in respect of **Anchal Misri, Vishal Pandita and Ashoo Pandita S/o Badri Nath Pandita** figuring at **S.No. 44, 59 & 9/Wait** in District Cadre Baramulla & Anantnag respectively has been rectified, whose names were notified vide this office notification bearing No. DSEK/Estt/III/B-Trs/PMP/PP/28-39 dated 04.01.2018 and No. DSEK/Estt/III/B-Trs/PMP/017/423-25 dated 10.02.2018. Besides, vide SSB's communication No. SSB/Secy/Sel/2017/1047 dated 23.01.2018 conveyed by Administrative Department vide No. Edu-I/56/2017 dated 28.03.2018, clarification with regard to marks variation in respect of **Rahul Koul S/o Avtar krishan Koul** figuring at **S.No. 6** in District Cadre **Bandipora** has been conveyed.

Now, therefore, sanction is hereby accorded to the provisional appointment of **Eight (08) candidates** (whose full particulars are reproduced below) as **Teachers** in **District Cadre Srinagar/Baramulla/Anantnag/Bandipora** against the additional posts created under Prime Minister's Special Package for Kashmiri Migrants as per the Annexure to this order in the pay scale of Rs.5200-20200 (Pre-revised) with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the concerned Chief Education Officers, within **Twenty-one (21) days** from the date of issuance of this provisional appointment order for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates are received from the concerned issuing authorities.

The provisional appointment shall be subject to the following conditions:-

- The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, Jammu & Kashmir, to whom a reference shall be made by the concerned Chief Education Officer; his/her appointment shall be itself stand cancelled abinitio and he/she shall have no claim of his/her appointment.
- The verification of qualification certificates/reserved category certificate (wherever applicable) from the concerned issuing authority.

The Chief Education Officer, concerned shall allow the candidates to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- Qualification certificates viz Degree/Marks
- Permanent resident certificates
- Migration Certificate whereunder eligible for seeking employment under Prime Minister's Special Package for Kashmiri Migrants.
- Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates,
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary till issuance of such orders shall be drawn.

The provisional appointee shall have to work in the respective district of appointment in the Kashmir Valley and shall not be eligible for transfer outside the district under any circumstances. In case the appointee migrates from Kashmir Valley at any time during his/her service tenure, for any reason whatsoever, his/her appointment/service shall stand terminated without any notice by itself by the acton of his /her migration, in terms of the agreement executed by each appointee under SRO-412;

The seniority of the appointee shall be fixed at the places on the posts of their first appointment in that particular grade/service and the provisional appointee shall be on probation initially for a period of Two-years.

The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court which are not immediately within the knowledge of this Directorate.
