Subject:- Provisional appointment of Junior Assistant (Education Department) Selected by the J&K Services Selection Board Jammu, for District Cadre Anantnag, and operating of wait list, thereof.

Whereas, the Administrative Department vide letter No. Edu-1/61/2016, dated.22/03/2016 has forwarded J&K Secretary Service Selection Boards Jammu communication No.SSB/Secy/Sel/2016/2051-57 dated. 08/02/2016, along-with list of **(17) (OM=15, RBA = 02)** candidates, who have been selected as Junior Assistants in District Cadre Anantnag;

Whereas, the said selection list was notified, through information department vide this office notification No.DSEK/NT/SSB/JA/510/2016/All/784-85 dated.07/04/2016, directed the selectees to deposit the requisite documents in original as well as self attested certificates/ testimonials in the directorate within 10 days from the date of publication of the notification in press.

Whereas, **(14) (OM=12, RBA = 02)** candidates deposited their requisite documents, and their provisional appointment orders were accordingly issued, vide order NO. 770-DSEK of 2016 dated 09/05/2016 and No. 944-DSEK of 2016, dated. 02/06/2016;

Whereas, remaining **(OM=03)** candidates out of **(OM=14)** selectees failed to deposit their documents in this Directorate within the stipulated period, were given one more opportunity for depositing their requisite documents vide Notification No. DSEK/NT/SSB/JA/510/2016/All/923, dated.06/05/2016.

Whereas, **(OM=03)** selectees again failed to submit their documents in the Directorate within the stipulated period, presumed that these selectees were not interested to join the Department;

Whereas, the matter was referred to the Administrative Department vide letter No.DSEK/NT/SSRB/ JA/510 /2016/All/1119 dated. 06/06/2016, for seeking instructions / orders with regard to operation of wait list, against the slot which become available due to non depositing of documents by these **(OM=03)** selectees;

Whereas, the Administrative Department vide letter No. Edu-1/61/2016 dated.04/06/2015, has conveyed approval for operating wait list against the slots on standard terms and conditions.

Whereas, **(OM=03)** candidates appearing in the wait list (District Anantnag) were asked to deposit their requisite documents in original as well as self attested certificates/ testimonials in the directorate within **10 days** vide this office notification No. DSEK/NT/SSRB/JA/510/2016/All/1583-84 dated. 24/09/2016;

Whereas, only two **(OM=02)** wait list candidates have deposited their documents/ undertaking in the Directorate, and their provisional appointment orders were issued, vide order No.1560in-DSEK of 2016, dated.08/11/2016 and No.1602-DSEK of 2016, dated.17/11/2016;

Whereas, one more opportunity was given to the remaining **(OM=01)** wait list candidate for depositing his requisite documents vide this office notification No. DSEK/NT/SSB/JA/510 2016/ All/2197 dated.28/11/2016, but the said candidate again failed to submit his documents within the stipulated period presuming that he is not interested to join the Department to avail the appointment as Jr. Assistant;

Whereas, **S.No. 04** under open merit category of wait list namely Sajad Iqbal Dar S/o Abdul Hamid Dar R/o Kredsalnani Anantnag was asked to deposit his original documents as well as self attested certificates/testimonials in this Directorate within 05 days from the date of publishing of this notice in press appeared in Daily Greater Kashmir on 09-12-2016 through Information Department vide this office notification No. DSEK/NT/JA/510/16/All/2406-07, dated 08-12-2016, but he has failed to submit his document in this Directorate within the stipulated period;

Whereas, Mr. Ishfaq Ahmad Wani S/O. Mohmad Ramzan Wani R/O. Sursuna Shamshipora Anantnag, who is next in queue in the wait list at S.No 05 under Open merit category, was asked to deposit his original documents as well as self attested certificates/testimonials in this Directorate within 05 days from the date of publishing of this notice in press, appeared in Daily Rising Kashmir on 29-12-2016 through Information Department vide this office notification No. DSEK/NT/JA/510/16/All/2511-12 dated 26/12/2016, Accordingly the said candidate has deposited his documents for issuance of his provisional appointment order;

Now, In view of the above, Sanction is hereby accorded to the provisional appointment of Ishfaq Ahmad Wani S/O. Mohmad Ramzan Wani R/O. Sursuna Shasipora Anantnag, selected candidate, figuring at S.No. 05/Wait under OM Category as Junior Assistant in District cadre Anantnag, in the pay band of Rs.5200-20200+ grade of Rs.1900/-. The candidate is required to report to the Chief Education Office **Anantnag** within **10 days** from the date of issuance of this Order, for further posting against the available vacancies in needy institution, on his own risk and responsibility till the verification/authentication of all relevant documents/Certificates are received from the concerned agencies.

The appointee shall be governed under New pension Scheme as per SRO-400 of 2009 dated.24.12.2009.

The appointment of the candidate shall be on probation for a period of two years and subject to production of following certificates (in original) before the Chief Education Officer **Anantnag** who shall be required to get these certificates verified / authenticated from the concerned issuing authorities

- ❖ Character and antecedents certificate from Additional Director General of Police (CID).
 - ❖ Qualification certificates.
 - ❖ Permanent resident certificate
 - ❖ Age and health certificate
 - ❖ Discharge certificate from the Institution attending/ last attended
 - ❖ Certificates from District Industries Centre/Employment Exchange to the effect that no loan under-self employment scheme has been taken by the appointee.
 - ❖ Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks obtained and percentage of the selectee in consonance with the merit list authenticated from the original certificates.

The salary of the appointees shall not be drawn and disbursed unless;

- Satisfactory report about his character and antecedents is received from the concerned Additional Director General of Police (CID) J&K. and genuineness/ verification report for qualification certificates /Technical Certificate /Marks Certificates and category certificates (if any) from the issuing authority.
- He shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from the concerned Additional Director General of Police (CID) J&K , the appointee shall have no right to claim his appointment as Jr. Assistant and appointment as such shall be deemed to have been cancelled ab-initio.
- The Chief Education Officer, **Anantnag** will adjust the candidate against clear vacancy in needy institutions without involving transfers.
- He shall give an undertaking duly attested by the Judicial Magistrate 1st Class that he will not apply for transfer from District **Anantnag** in any case, and in case, at any stage it emerges that the certificates/ any relevant document furnished/ produced by the selectee is fake / fictitious, the appointment order shall be cancelled abinitio and criminal proceeding shall be initiated against the candidate

After receiving verification report viz; date of birth, qualification, marks, category and other Certificates from the issuing authority through concerned CEO duly counter-signed, formal appointment order will be issued accordingly and no salary will be drawn in favour of the candidate till formal appointment order is issued from this Directorate.

The inter-se seniority of the appointee shall be in the order in which his name appear in the select list furnished by the J&K Services Selection Board.

The appointment of the candidate shall be subject to outcome of any writ petition(s)/, if any, pending in ay court of competent jurisdiction.
