Sub: Fake Marks Certificate produced by Shri Amit kachroo, Teacher (PM's Package) GHS Panthachowk District Cadre Srinagar and issuance of termination order thereof..

Whereas, among others **Shri. Amit Kachroo S/o S.N. Kachroo R/o: Kani Kadal Srinagar** was provisionally appointed as Teacher in District Cadre Srinagar (under PM's Package) vide this office Order No. 897 DSEK of 2018 Dated: 07/07/2018 pursuant to his selection made by the JKSSB and in light of instructions conveyed by the Administrative Department vide their communication dated 27/04/2018 wherein his particulars were reflected as under:-

Whereas, the appointee was subsequently posted in High School Panthachowk by the Chief Education Officer Srinagar on 02/08/2018, giving the joining date as 12/07/2018; and

Whereas, after verifying the testimonials/documents of the said appointee from the issuing authority, the Chief Education Officer recommended the case for issuance of formal appointment order vide his communication No. CEO/Sgr/Estt/Apptt/5378 dated: 29/05/2019; and

Whereas, the provisional appointment order of the said appointee among others was confirmed by this office vide order No. 551-DSEK of 2019 dated :19/07/2019 with the condition that the order shall be implemented after fulfillment of all terms and conditions as laid down in the provisional appointment order; and

Whereas, the Chief Education Officer, Srinagar vide his communication No. CEO/Sgr/Estt/3498 dated: 18/03/2020, reported that the marks certificate of BA Part-III of the said appointee was re-verified from the University of Jammu by the Drawing and Disbursing Officer and was found "FAKE"; and

Whereas, the pending enquiry into his conduct, the teacher was placed under suspension and attached with Directorate of School Education Kashmir with immediate effect and subsequently Mr. S.D.Bhat Joint Director (SAMAGRA) was appointed as Enquiry Officer to conduct preliminary enquiry in the matter vide this office order No. 352-DSEK of 2020 dated 29/10/2020; and



Whereas, the Enquiry Officer has furnished its report on 16/08/2021 and has established that the said teacher has managed his selection through JKSSB by production of FAKE B.A. Part-III marks certificate (under Roll No. 107766 through Jammu University). Further it has been stated that the teacher has deceived the Department and drawn his huge salary from the Government Ex-chequer w.e.f. 07/07/2018 to 31/01/2020 fraudulently; and

Whereas, the confirmation to the provisional appointment order which was issued by this office on 19/07/2019 on the basis of verification reports of certificates/documents was withdrawn by this office vide order No. 685 of DSEK Dated: 20/10/2021 ab-initio; and

Whereas, this office issued a termination notice to the said teacher on 02/11/2021, wherein he was giving an opportunity to show cause as to why his service shall not be terminated which was supposed to reach this office within 07 days from the date of issuance of the said notice, failing which it shall be construed that he has nothing to say in his defence and action as warranted under rules shall be followed without any further notice; and

Whereas, the office has not received any response from the said incumbent within the stipulated period of time indicating thereby that he has nothing to say in his defence for producing fake/fraud B.A. Part-III marks certificate on which basis he managed his selection through JKSSB as Teacher in District Cadre Srinagar (under PM's Package) for Kashmir Migrants on 07/07/2018 and as such his appointment needs to be rescinded; and

Now therefore, on the basis of findings of the enquiry report submitted by the Joint Director (SAMAGRA) DSEK on 21/08/2021, the services of *Shri Amit kachroo, Teacher (PM's Package) GHS Panthachowk District Srinagar is hereby terminated ab-initio.*
