Whereas, in terms of J&K School Education (Subordinate) Non-Gazetted Recruitment Rules issued under SRO-308 of 2008 Dated: 16/10/2008, joint seniority of different categories of Class-IV employees viz Peon, orderly, Safaiwala, Gardner, Chowkidar, Lab. Bearer, Lib. Bearer, Gasman, and others was framed for their promotion to the next higher post, i.e. Lab. Assistant, Junior Assistant and Library Assistant.

Whereas, the department vide order No. 2149-DSEK of 2013 Dated: 07/11/2013 had placed 57 (Fifty Seven) Class-IV of District Anantnag to their next cadre as I/C Junior Assistants, I/C Lab. Assistants on strict seniority in OPG on stop gap arrangement basis; temporarily for a period of six months or till the posts are filled up by the concerned DPC, which ever earlier.

Whereas, the said temporary placement has come under severe criticism due to the reason that sizeable number of Class-IV employees in District Anantnag have been dropped out, for their elevation to the next cadre despite having comparative seniority and eligibility with their counterparts for non-submission of their service particulars by the respective DDO's at the time of their elevation in the year 2013.

Whereas, in order to consider the claim of genuine dropouts on the available promotion quota posts, a notification was issued by the Department and got published in Press appeared in Daily Greater Kashmir on 04/02/2016, directing the Class-IV of District Anantnag to furnish their claim/Service particulars through concerned Chief Education Officer.

Whereas, the matter was placed before DDPC in its meeting held on 06/01/2018. The DPC after having the deliberations over the matter has observed that huge dropage of Class-IV has happened in District Anantnag in the year 2013, on one pretext or the other and there are less vacancies than the actual number of dropouts in the district.

Whereas, the DPC has decided to frame a fresh seniority list of qualified Class-IV including those placed to the next higher post in the year 2013, to draw a list of overall Class-IV in terms of their seniority to determine their entitlement to the placement against the actual posts in hand.

Whereas, the Chief Education Officer Anantnag furnished updated joint seniority list of Class-IV on 01/11/2018, alongwith vacancy position under promotion quota.

Whereas, the matter was again placed before DDPC in its meeting held on 18/04/2018. The DPC after threadbare discussion and considering the rule position and lien free vacancy position, agreed to grant confirmation/promotion of **19 (Nineteen)** Incharge Lab. Assistants and **36 (thirty-six)** drop out Class-IV as Lab. Assistants as per strict seniority in District Anantnag.

Now, therefore, as approved by the Divisional Departmental Promotion Committee, sanction is hereby accorded, to the confirmation/promotion of eligible Class -IV as Lab. Assistants as per the annexure "A" and "B" to this order.

Before implementing the orders, the CEO/DDO concerned shall verify the particulars of the officials with reference to their original documents/service books. The deviation, if any noticed be reported to this Directorate for necessary clarification.

The Confirmation/promotion shall be further subject to the following explicit conditions:


- The confirmation/promotion shall be without prejudice to the final outcome of the case, if any sub-judice/impugned or pending before the Hon'ble Court or any other court and other orders, if any passed by the competent authority, which may not be immediately within the knowledge of this Directorate.
- The Chief Education Officer concerned must ensure that there is nothing adverse against the promotees from the VoK/Crime/Police.
- The promotees must necessarily be holding substantive genuine appointment and un-interrupted service. The benefit of confirmation/promotion shall not be allowed in case the official(s) are under suspension or in case of the official(s) against whom departmental proceeding may be pending or whose work and conduct may not be satisfactory.
- The Migrant Class-IV placed as Lab. Assistants, shall report to the concerned CEO alongwith service book and all other allied documents/certificates within 10 days from the date of issuance of this order, after getting themselves properly relieved by the concerned DDOs and countersigned by the Joint Director In-Charge Migrant Cell Jammu, for seeking their formal posting orders in the District, failing which it shall be construed that they are not willing to avail the benefit of this promotion and their promotion as such, shall be deemed to have been cancelled ab-initio without issuing further orders in this behalf.


