Whereas, Shri Mudasir Ahmad Dar S/o Ghulam Ahmad Dar R/o Rahmoo Pulwama (hereinafter referred to as 'absentee') was selected as Lab. Assistant by the J&K SSB and appointed by this office vide Order No: 1270-DSEK of 2018 Dated: 06/10/2018 in terms of SRO-202 of 2015 and was accordingly adjusted in High School Parigam Pulwama by the Chief Education Officer Pulwama vide communication No: CEO/PUL/NT/18/287/2701-04 Dated: 15/11/2018.

Whereas, absentee joined the High School Parigam Pulwama on 15/12/2018 and thereafter he proceeded on un-authorized absence from his legitimate duties w.e.f. 19/03/2019.

Whereas, absentee was served with show cause notices dated 06/04/2019 and dated: 24/04/2019 by the Headmaster, High School Parigam and final notice in this regard was issued on 29/05/2019 which however, evoked no response from the absentee.

Whereas, by virtue of appointment order bearing No: 127-DSEK of 2018 dated: 06/10/2018, absentee was on probation for a period of five years in terms of SRO-202 of 2015.

Whereas, in view of un-authorized absence from the legitimate duties of the absentee during the probation period it is not deemed fit to initiate formal departmental enquiry against the delinquent official.

Now, therefore, in terms of the provisions of J&K Civil Services (CC&A) Rules, 1956 Shri Mudasir Ahmad Dar S/o Ghulam Ahmad Dar R/o Rahmoo, Pulwama who was last posted as Laboratory Assistant in Government High School Parigam Pulwama is hereby, terminated from services w.e.f. 19/03/2019 for wilfully remaining on un-authorized absence from his legitimate duties during probation period w.e.f. the date mentioned above.


