As recommended by the committee constituted vide Order No 472-DSEK of 2017 Dt.16.02.2017 sanction is hereby accorded to the appointment on Compassionate grounds in favour of Mr Bilal Bashir Wani 10th Pass S/o Mr. Bashir Ahmad Wani & Hajra Begum (deceased Class IV, Orderly HS, Andergam) R/o Andergam Tehsil Pattan District Baramulla as Class-IV (Lab. Bearer) in the pay scale of Rs. 4440-7440 with grade pay of Rs 1300/= (**pre-revised**) against the post in HS Khawajabagh. The appointee shall be on probation for a period of two years.

The appointee shall be allowed to join only after production/ verification of the following certificates in original:

- i. Age and health certificate
- ii. Educational qualification certificate (from recognized / Board/ University)
- iii. Character/ Antecedents Certificate.
- iv. Date of Birth Certificate
- v. Permanent Resident Certificate
- vi. No Loan Certificate
- vii. Affidavit duly Sworn in before Judicial Magistrate to the effect that in the event of his failure to look after the deceased's family his appointment shall be cancelled.
- viii. If on verification, the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled ab-initio.

In case the appointee fails to join and produce the certificates within 21 days from the date of issue of this order, **the order will cease** to operate without any further notice to the appointee. The candidate be allowed to join provisionally in absence of verification of his character/ antecedents is received from the CID. However, his pay shall not be drawn and paid till the verification of his character/ antecedents is received from the CID. In case of adverse report from the CID, the order will be deemed to have been cancelled & will have no claim for Salary for the period he worked, and an undertaking to this effect be also obtained from him for record and reference.


