**Subject:- Placement of PG Masters/ Teachers as I/C Lecturers in the discipline of Physics.**

**Government Order No.:- 91 - Edu of 2016**  
**Dated :- 18 - 03 - 2016**

On the basis of seniority/ eligibility and as per the seniority list notified vide Government Order No. 90 -Edu of 2016 dated 18 -03-2016, the P.G. Masters/ Teachers figuring in the **Annexure "A"** are hereby placed as I/C Lecturers in the discipline of **Physics** in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier. These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be subjudice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions within 21 days from the date of issuance of this order. Any I/C Lecturer who fails to report within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will verify the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**Physics**).

That the in-service candidates who have acquired P.G Degree after availing the leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave, their officiating placement shall be deemed to have been cancelled ab-initio. The Director School Education shall immediate revert him back to his original place of posting under intimation to the Administrative Department.

- (iii) That the in-service candidates who have acquired P.G Degree after availing the leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission from competent authority or they had not availed proper leave, their officiating placement shall be deemed to have been cancelled ab-initio. The Director School Education shall immediate revert him back to his original place of posting under intimation to the Administrative Department.
- (iv) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid and validity of category certificate(s), if any, shall be determined by the concerned Directorate of School Education.

- (v) The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc).

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by an Official before he/she proceeds for his posting as shown in Annexure "A" or is posted onwards, wherever indicated, by the Directorate. If any of the above mentioned conditions is not fulfilled by an Official, he/she will not be allowed to join and such cases shall be referred to Administrative Department for further action.

The case of those PG Masters/ Teachers who have done post graduation through distance mode will be considered after verification of their documents and fulfillment of criteria laid down vide Government Order No. 252-HE of 2012 dated 30-12-2012.

The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.

The transferees to Leh and Kargil Districts are allowed to travel by air for joining at their new place of postings.
