Subject:- Placement of Masters as I/C Headmasters and Equivalent.

Order No. 928 DSEK of 2016
Dated: - 30/05 / 2016

Whereas, on the basis of strict seniority/eligibility/suitability 57 Masters which includes 13 Migrants were placed as I/C Headmasters & Equivalent vide Order No. 2767 DSEK of 2016 dated:- 18-11-2015 under General category and reserving required number of posts for different categories as per roster in anticipation of orders of High Court;

Whereas, one Farooqa Jan represented this office that she can not avail the placement in view of her ailment and did not join the designated place of posting;

Whereas among the (13) migrant promotees only (01) Master joined the designated place of posting and the rest 12 promotees failed to report for duty at designated place of postings in Kashmir Division;

Whereas, the matter of non-joining was taken up with Director School Education, Jammu, and Joint Director, Migrant Cell, Jammu vide letter No. DSEK/ZEO-HM/3038 dated: - 26-02-2016 with the request to direct/give chances to these promotees to join the School where they were posted;

Whereas, the joint Director migrant Cell Jammu vide letter No. DSEJ/2074 dated:- 27-02-2016 intimated that all the promotees were informed but they failed to comply the orders;

Whereas, despite lapse of considerable time these promotees did not join & the institutions suffered a lot on account of non-availability of their own DDO's, defeating very purpose of above said arrangement;

Whereas, one Mr. Mohammad Maqbool Mir, Master BHS Wadwan, Budgam figuring at Sr. No. 17 in the seniority list of Masters represented this office stating that his date of 1st appointment as Teacher is 14-12-1985 and date of promotion as Master 04-09-2004 instead of 04-10-2004 and requested for re-fixation of his seniority.

The matter was re-examined on receipt of report from the Chief Education Officer, Budgam;

Whereas, on the basis of documentary evidences and verification of service records the seniority of Mohmmad Maqbool Mir, Master BHS Wadwan has been re-fixed at Sr. No. 01 in the seniority list notified by this Directorate vide No. DSEK/Gaz/ZEO-HM/3076 dated:- 06-04-2016 and the seniority of Sr. No. 01 viz. Mohmmad Maqbool Mattoo, Master MS Rakhayan fixed at Sr. No. 01-(A).

Now, therefore, in view of the circumstances explained above, sanction is hereby accorded to the withdrawal/cancellation of placement of the following promotees with immediate effect:-
