Whereas, among these Thirty (30) selectees, Eleven (11) candidates in District Cadre Srinagar and One (01) candidate in District Cadre Shopian has been selected as teachers against Item No. 836 & 830 respectively,;

Whereas, the recommendation in respect of Tabasum Habib D/o Habibullah Shah figuring at S.No. 06 under OM Category and Rehana Jabeen D/o Gh. Whereas, vide this office notification No. DSEK/Estt/III/B-Trs/237-40 dated 04.05.2016 published in local dailies, the above selectees were advised to submit their documents/papers in the Directorate of School Education Kashmir within Seven (07) days from the date of publication of notification;

Whereas, in response to the said notification dated 04.05.2016, both the selectees furnished their undertakings on the devised format duly attested by the 1st Class Magistrate alongwith self-attested copies of all requisite documents/certificates;

Now, therefore, in pursuance to the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, sanction is hereby accorded to the provisional appointment of Tabasum Habib D/o Habibullah Shah figuring at S.No. 06 under OM Category and Rehana Jabeen D/o Gh. Ahmad Ahanger figuring at S.No. 1 under RBA Category (whose full particulars are reproduced below) as Teacher in District Cadre Srinagar and Shopian respectively, in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under–Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to the concerned Chief Education Officers by or before 10th June, 2016 for seeking further posting on his own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies.

The concerned Chief Education Officer shall allow the candidate to join on the post after verifying the following certificates (in original).

- Character and antecedents certificates from Additional Director General of Police (CID)
- · Qualification certificates viz Degree/Marks
- · Permanent resident certificates
- · Age and health certificates
- Discharge certificate from the Institution attending/ last attended
- Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.
- Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.
- Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing
  authority and ensure that the merit points reflected in the selection list are recorded according to the
  genuineness marks card /qualification certificate.
- The selectee shall give an undertaking by way of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.

## The salary of the appointee shall not be drawn unless:

- Satisfactory report of his/her character and antecedents is received from the concerned Additional Director General of Police (CID) J&K, and genuineness/verification report of qualification/marks certificates/category certificate/ date of birth certificate etc. from the issuing authority.
- In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.
- The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.

The formal appointment order of the candidate shall be issued only after receiving verification reports viz date of birth certificates / qualification/marks certificate/category certificate and other (if any) from the issuing authority through concerned Chief Education Officer and no salary shall be drawn till issuance of such orders.

The inter-se seniority of the appointee shall be in order in which his name appear in the select list furnished by J&K Services Selection Board and the appointees/selectee shall be on probation for a period of **Two** years

The provisional appointment of candidates is subject to the final outcome of any writ petition(s), if any, pending before in any Court of competent jurisdiction.
