Whereas the Administrative Department vide letter No. Edu-I/35/2016 dated: 01.04.2016 forwarded J&K Secretary Service Selection Board's communication No.: SSB/Secy/Sel/2015/18035-41 dated: 31.12.2015 alongwith a list of **Eighteen (18)** candidates who have been selected as teachers in District Cadre Budgam in pursuance to Advertisement Notification No. 08 of 2013 under Item No. 673.

Whereas, among these **Eighteen (18)** selectees, recommendation in respect of **Three (03)** candidates has been kept withheld by the SSB for want of some clarification;

Whereas, vide this office notification No. DSEK/Est/III/B-Trs/Fresh-selection/200-04 dated 28.04.2016, the **Fifteen (15)** selectees, in whose favour recommendation was not been kept withheld were advised to submit their documents/papers in the Directorate of School Education Kashmir within **Seven (07)** days from the date of publication of notification published in local dailies;

Whereas, in response to the said notification dated 04.05.2016, **Fourteen (Out of 15)** selectees furnished their undertakings on the devised format duly attested by the 1st Class Magistrate alongwith self-attested copies of all requisite documents/certificates, leaving **One (01)** candidate who failed to do so and in respect of **One (01)** candidate some discrepancy has been found which needs clarification from the Administrative Department/SSB;

Whereas, out of **Fourteen** selectees, some discrepancy has been found in respect of **One** candidate as such only **Thirteen (13)** candidates were found eligible for consideration of provisional appointment;

Now, therefore, in pursuance to the recommendations of the SSB/Administrative Department conveyed vide aforementioned communications, sanction is hereby accorded to the provisional appointment of **Thirteen (13) candidates** (Detailed in Annexure to this Order) as Teachers in District Cadre **Budgam** in the pay scale of Rs.5200-20200 with grade pay of Rs.2800 and 2400 for Graduates and above and Under-Graduates respectively, admissible under SRO-93 dated 15.04.2009. The candidates are required to report to Chief Education Officer Budgam by or before **10th June, 2016** for seeking further posting on their own risk and responsibility till the verification/authentication of all relevant documents/certificates is received from the concerned agencies. The appointment shall be subject to the following conditions:-

- i. *The appointees/selectee shall be on probation for a period of two years.*
- ii. *The appointees shall be governed under New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.*
- iii. *In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is fake/fictitious, the appointment order shall be cancelled abinitio and criminal proceedings shall be initiated against the candidate.*

- iv. *The selectee shall give an undertaking by way of affidavit duly attested by the Judicial Magistrate 1st Class to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.*
- v. *The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.*
- vi. *The appointee/selectee shall be posted in Teacher-deficit institutions in the District without involving chain of transfers.*

The Chief Education Officer, Budgam shall allow the candidates to join on the post after verifying the following certificates (in original).

- *Character and antecedents certificates from Additional Director General of Police (CID)*
- *Qualification certificates viz Degree/Marks*
- *Permanent resident certificates*
- *Age and health certificates*
- *Discharge certificate from the Institution attending/ last attended*
- *Certificate from the concerned authority to the effect that no loan under-self employment scheme has been taken by the concerned candidates.*
- *Category certificates (in case of reserved categories) under SRO 294 of 21/10/2005.*
- *Total Marks/Marks obtained and percentage of the selectee be also got verified/authenticated from the issuing authority and ensure that the merit points reflected in the selection list are recorded according to the genuineness marks card /qualification certificate.*

The salary in favour of the appointees shall be drawn only after receiving verification report of qualification/marks certificates/category certificate/ date of birth certificate etc. from the issuing authority and satisfactory report of their character and antecedents/verification from the concerned quarter. Variation if any, found in the particulars of any candidate, that should be brought into the notice of Directorate and order shall not be implemented till clarification is issued by this office.


The provisional appointment of candidates is subject to the final outcome of the cases, if any, pending before in any Hon'ble Court.
