Disciplinary action or proceedings if and when warranted, shall be conducted consistent with the due process of law and also notified to the CEO/ZEO concerned,
- Deposit with the respective office due share/ subscription on account of Games / Red cross fund in terms of the VIII.orders / instructions in force,
  - Furnish correct and complete information as per format provided to CEO/ZEO concerned for updation of IX. District Information System of Education (DISE) and Education Management Information System (EMIS) against proper official receipt,

Any deviation or default in adherence to the norms/rules laid down and the orders / instructions issued from time to time shall render the School liable for strict action which may include withdrawal of recognition, besides other penal action under law/rules.
